



OVERVIEW: Chatham County's Education Impact Fee

WHAT IS THE SCHOOL IMPACT FEE?

The impact fee is one of the county's few alternatives to the property tax for meeting revenue needs to increase school capacity. The fee is collected from builders to fund the impact of development on school facility needs.

The county first received authority from the General Assembly to collect the fee in 1987, but did not begin collecting it until 1999. In 1996, a study was conducted to determine the impact of new houses on schools. The county had not updated the study until this year, but the commissioners asked for the update due to major increases in school construction costs, which have nearly doubled since 1996.

QUICK FACTS

- It has funded 17 projects during that period, including Virginia Cross Elementary, a new cafeteria at Jordan Matthews and the purchase of land for a new high school. See list on back page.
- Through 2020, an estimated \$42.7 million will be needed for debt service on projects recently completed or underway.
- The current impact fee level is based on outdated construction costs from 1996.
- State law does not allow the county to vary the fee based on home price or income of the buyer. Square footage is not legally an option either, because the county can't show the linkage between the number of students and square footage of housing.
- However, the county can consider the number of bedrooms as an option for varying the fee to be more equitable.
- The county also can vary WHEN the fee is collected, such as when the permit is obtained or later in the process.
- The maximum levels of the fee allowed in the study (see back side) are maximum authorized limits, not a proposal by the Board of Commissioners. The commissioners are seeking public input to guide any decision made on changing the fee.

KEY QUESTIONS

- **HOW TO PAY FOR SCHOOLS?** If additional revenues are needed for new schools, should Chatham County increase the impact fee or increase property taxes to pay for new school construction? If residents do not like either option, what suggestions do they have for meeting school facility needs for students?
- **SHOULD THE FEE VARY BY TYPE OR BEDROOMS?** Should the county base the impact fee on the number of residential bedrooms, the only legal option to link the fee to home size or affordability? Or, should it continue to use the type of housing (single or multi-family) as the basis for the fee?
- **WHEN SHOULD THE FEE BE COLLECTED?** Should the impact fee be collected when the building permit is obtained or at some other point, such as when the certificate of occupancy is granted? Or should it be combination of one or more options?
