# MINUTES CHATHAM COUNTY BOARD OF COMMISSIONERS REGULAR MEETING JULY 20, 2009

The Board of Commissioners ("the Board") of the County of Chatham, North Carolina, met in the District Courtroom, 12 East Street, located in Pittsboro, North Carolina, at 6:00 PM on July 20, 2009.

#### INVOCATION AND PLEDGE OF ALLEGIANCE

Commissioner Mike Cross delivered the invocation after which Chairman Lucier invited everyone present to stand and recite the Pledge of Allegiance.

#### **CALL TO ORDER**

The meeting was called to order by the Chairman at 6:04 PM.

#### **APPROVAL OF AGENDA and CONSENT AGENDA**

Commissioner Vanderbeck asked that Item #6, approval of a grant application for the Solid Waste/Sustainable Communities for the "Climate Showcase Communities" to fund a Zero Waste Coordinator position within Waste Management be removed from the Consent Agenda and placed on the Regular Agenda after the Public Input Session for discussion and that consideration of providing comments to the Town of Cary on a pending annexation on Pittard Sears Road (from the afternoon Work Session) be added to the Agenda after the Public Hearing.

#### **PUBLIC INPUT SESSION**

**Helen McNeil**, 1704 North Chatham Avenue, Siler City, NC, thanked the Board for allowing her the opportunity to speak. She introduced Mr. Matthews and turned the floor over to him for comments.

**Frankie Matthews**, 828 Lane Jordan Road, Siler City, NC, President of the Neighborhood Community Center, Siler City, NC, voiced concern with regard to delinquent property taxes.

Public Hearing:

Public Hearing to Rezone Acreage: Public hearing to receive public comments on a request to rezone a portion of parcel #18402 (consisting of approximately 30 acres), owned by Joanna Bright and Walter Anthony Bright, Trustees, from R-1, Residential, to Light Industrial

**Bill Causey**, 2734 River Forks Road, Sanford, NC, adjacent property owner, spoke in opposition of the rezoning to light industrial.

**Kathleen Hundley**, 136 Rocky Falls, Sanford, NC, asked that the Board refrain from individual rezoning requests and consider the long-term benefits of a Major Corridor Ordinance along the major corridors in the County.

**Sonny Keisler**, 3006 River Forks Road, Sanford, NC, encouraged the Board to refrain from rezoning any properties within the Highway 15-501 R-40 corridor south of Pittsboro until a major highway corridor ordinance has been completed and enacted.

**Debby Wakefield**, 1412B River Forks Road, Sanford, NC 27330, encouraged the Board to refrain from rezoning to light industrial.

**Anthony Bright**, 1305 Walter Bright Road, Sanford, landowner, offered comments to explain his request to rezone the property.

Barbara Ford, Planning Board Member, asked questions of Mr. Bright.

The Chairman closed the public hearing.
