**Public Hearing for Conditional Use Rezoning on Old Farrington Road:** Public hearing to receive public comments on a request by Brian Sawyer for a conditional use rezoning on Parcel 82735, located at 525 Old Farrington Road, Williams Township, from R-1 Residential to Conditional use Neighborhood Business (CU-NB), on approximately 1.16 acres

Jeffrey Starkweather stated that with regard to conditional use permits, he feels that the applicants should have to spell out specific uses; that it is hard to read a long list of uses and know what is going to happen; and that it would be easier to compare the specifics with the acceptable uses in order to know what is going on.

**Public Hearing for Conditional Use Rezoning on US Highway 15-501:** Public hearing to receive public comments on a request by Kenneth Hoyle and Floyd Coleman for a conditional use rezoning on Parcel 2759, located at 9555 US Highway 15-501 North, Baldwin Township from R-1 Residential to Conditional Use Neighborhood Business (CU-NB), on approximately 2.285 acres

Mr. Sullivan explained the specifics of the request.

Bonnie Strowd, 9515 Highway 15/501, Chapel Hill, NC, stated that she owns "Bathrooms by Bonnie" located south of the applicant's property and that she has no objections and is in complete support of their request for rezoning.

Ken Hoyle, applicant, answered questions from the Board of Commissioners and members of the Planning Board.
