Change to Water Extension Contract on Old US #64 Extension Project: Consideration of approval of a change in the scope of the Water Extension Contract on the Old US #64 Water Extension Project (Contract XIII) to Terry's Plumbing and Utilities, Inc., 465 Lewallen Road, Asheboro, NC 27203, C. Terry Tucker, President, for extending a 6" water line along Frazier Store Road (SR #1105) between Old US #64 (SR #1107) and US Hwy. #64 West of Siler City and a 2" line eastward on US Hwy. #64

Commissioner Pollard moved, seconded by Commissioner Grimes, to approve a change in the scope of the Old US #64 Water Extension Project to install water mains along Frazier Store Road (SR #1105) and US #64 and to approve a Change Order in the amount of \$29,530 (plus or minus) to Terry's Plumbing and Utilities, Inc., subject to review and approval of the Change Order by the County Attorney and to authorize the Interim County Manager to sign the change order. Interim County Manager Robert Gunn informed the Commissioners that the owner of the land on Cardinal Street which is needed to make a "through" street by the new Siler City Health Building is not willing to sell at a reasonable price; and that the County will probably have to forego making it a through street to Cardinal; that Lex Kelly has this information and is working on the design of the street.
