GIS Mapping/Letter of Intent

Kenneth Joyner, Chatham County Tax Administrator, explained that the Tax Administration Office is requesting that the Commissioners grant a letter of intent to contract with American Geographic Data for the production of aerial photography for the County. He stated that this is part of the mapping Request for Proposals (RFPs) that the County sent out in December, 1996; that by granting the "Intent to Contract..." the County is liable for \$21,292, not the entire project; that the reason for moving forward at this point is that the time frame to complete aerial photography is coming to an end for the 1997 year; and that the flying season for aerial photography is from February 1, 1997 to March 15, 1997.
