# MINUTES CHATHAM COUNTY BOARD OF COMMISSIONERS REGULAR MEETING, FEBRUARY 13, 1995

The Board of Commissioners (the "Board") of the County of Chatham, North Carolina, met in regular session in the District Courtroom, located in the Courthouse Annex, Pittsboro, North Carolina, the regular place of meeting, at 10:00 a.m., on February 13, 1995.

The meeting was called to order by the Chairman at 10:02 a.m.

# **AGENDA**

The Chairman asked if there were additions, deletions or corrections to the Agenda.

The County Manager recommended one additional item to consider setting a public hearing for the University Water Shed for the February 27th meeting, to be added to the end of the agenda.

Commissioner Dunlap asked to add a discussion of the Crutchfields Crossroads Collection Center to the agenda.

Commissioner Pollard asked to add a discussion of renaming a road to the agenda.

Commissioner Pollard moved to approve the agenda with the noted requests. Commissioner Wilson seconded the motion. The motion carried five (5) to zero (0).

# **CONSENT AGENDA**

The Chairman directed the Clerk to the Board to read the Consent Agenda.

#### **PUBLIC INPUT SESSION**

**Jacob Bass**, 617 Barnsley, Fearrington Post, Pittsboro, NC, voiced his concern regarding his property revaluation increase by 36% from \$230,600 to \$313,400. He informed the Board of the problems he had incurred with Tax Management Associates, Inc. during the past eleven weeks. He stated that he had placed numerous telephone calls to Charles Long, Director of Appraisal Services with Tax Management Associates, Inc. but that none of his calls were returned; that he had been informed that his house had been reappraised during a drive-by visit; that he has the form to request an appeal which will be mailed by the end of February; that he wants a fair reduction of his taxes; that he is surprised that the County has an organization like Tax Management doing such lax work and is supported by the County Manager; that he is prepared to take his case to the NC Property Appeal Board.

The County Manager stated that it was his recollection of his conversation with the Fearrington Homeowners Association that the County emphasis was on the appeal process and that they had been told that was the process that had to be taken. At some time after the claims are filed on the March 1st deadline, there may be some opportunity to resolve some situations prior to it going to the Board of Commissioners,

but not prior to that time. But that it would be inappropriate, probably illegal, to make any adjustments prior to the filing of the required forms and review by the tax office.

**Jim Diggs**, Route 6, Box 375, Chapel Hill, NC asked what is happening to our address numbering system; He stated that the Chapel Hill Telephone Directory changed all of the numbers in the telephone book; that the telephone bills were delivered to the

new, non-authorized addresses and were then returned by the postal service. He stated that he is seeking information as to what is happening with the addressing system and what is wrong with it.

# PRESENTATION BY PETER BATTIS

**Presentation by Peter Battis, Director of Chatham Counseling Center:** Consideration of a proposal for additional Mental Health Outreach Program

Peter Battis, Director of Chatham Counseling Center, stated that in keeping with the legislature's intention to improve crisis prevention services to identified high risk adult clients, Chatham Counseling Center proposes to use the State and County funding to create a "mini-PACT" (Program for Assertive Community Treatment) program. He stated that they intend to create two case management positions who will each have a caseload of five high-risk clients and ten rest home clients; that high risk clients will be chosen by these criteria: (1) Frequent presentation in crisis; (2) History of multiple hospitalizations; (3) Not effectively served by traditional OP services; (4) Dual diagnosis; that the two case managers will combine efforts with a therapist and psychiatrist to form "mini PACT" teams which will continually evaluate the status of their high-risk clients, develop outreach and other services for each client, and maintain coverage for these clients from 8 am to 8 pm; that case managers will receive in-house training in all three disability areas.

Commissioner Wilson moved to approve the program and authorize them to proceed. Commissioner Pollard seconded the motion. The motion carried five (5) to zero (0).

# **HEALTH DEPARTMENT**

**Funds Acceptance from Smart Start:** Consideration of approval to accept Smart Start funds of \$11,880 to continue De Madres a Madres Program (From Mothers to Mothers) in Chatham County, Budget Amendment #25

Commissioner Wilson moved to approve the Chatham County Board of Health and the Health Director recommendation to accept the Smart Start funds to continue De Madres a Madres Program (From Mothers to Mothers) in Chatham County and approval of **Budget Amendment #25**. Commissioner Pollard seconded the motion. The motion carried five (5) to zero (0).

**Funds Acceptance from Smart Start:** Consideration of approval to accept Smart Start funds in the amount of \$28,835 to implement Family Ties Project in Chatham County, Budget Amendment #26

Commissioner Wilson moved to approve the Chatham County Board of Health and the Health Director recommendation to accept the Smart Start funds to implement the Family Ties Project in Chatham County and approval of **Budget Amendment #26**. Commissioner Pollard seconded the motion. The motion carried five (5) to zero (0).

**Funds Acceptance for Immunization Action Plan:** Consideration of approval to accept additional state funds of \$5,047 for Chatham County's Immunization Action Plan, Budget Amendment #27

Commissioner Pollard moved to approve the Chatham County Board of Health and the Health Director recommendation to accept the additional state funds for Chatham County's Immunization Action Plan and approval of **Budget Amendment #27**. Commissioner Wilson seconded the motion. The motion carried five (5) to zero (0).

**Funds Acceptance for Maternal Outreach Services:** Consideration of approval to accept grant funds of \$19,399 to enable the Health Department to offer Maternal Outreach Services, Budget Amendment #28

Commissioner Pollard moved to approve the Chatham County Board of Health and the Health Director recommendation to accept the grant funds to enable the Health Department to offer Maternal Outreach Services and approval of **Budget Amendment #28**. Commissioner Wilson seconded the motion. The motion carried five (5) to zero (0).

**Funds Acceptance for Environmental Health Services:** Consideration of approval to accept additional state funds of \$2,109.45 for Environmental Health Services, Budget Amendment #29

Commissioner Grimes moved to approve the Chatham County Board of Health and the Health Director recommendation to accept additional state funds for Environmental Health Services to be used for rewarding the Environmental Health Specialists with boots and jackets with any remainder to be used for office supplies or otherwise put into Fund Balance, and approval of **Budget Amendment #29**. Commissioner Wilson seconded the motion. The motion carried five (5) to zero (0).

**Funds Acceptance for Nutrition Services:** Consideration of approval to accept grant funds of \$5,000 to provide nutrition services to the school-based health center at Horton Middle School, Budget Amendment #30

Commissioner Pollard moved to approve the Chatham County Board of Health and the Health Director recommendation to accept funds to provide nutrition services to the school-based health center at Horton Middle School and approval of **Budget Amendment #30**. Commissioner Grimes seconded the motion. The motion carried five (5) to zero (0).

# **BOARD OF COMMISSIONERS' MATTERS**

**Criminal Justice Partnership Program Grant Application:** Consideration of the Criminal Justice Partnership Program Grant Application

**Deborah Giles**, thanked the Board for the opportunity to explain the County-based, community-driven, community-correction's plan. She explained that the community-correction's plan necessity has been driven by changes in the State's sentencing laws; that a grid was developed to define the levels of punishment received based on the type of crime and the amount of points received based on prior conviction levels and that the objective of structured sentencing is to take the guess work out of sentencing. She thanked Chairman Holland and the County Manager who have been actively involved throughout the process of putting together the program.

Commissioner Wilson moved to approve the grant application for the Criminal Justice Partnership Program and authorize the chair to sign the application, a copy attached hereto and by reference made a part hereof. Commissioner Pollard seconded the motion. The motion carried five (5) to zero (0).

The Chair called for a five minute recess in the meeting.

### **ECONOMIC DEVELOPMENT**

Recommended Changes in Guidelines for the Chatham County Guaranteed Loan Program for Small Businesses: Consideration of recommended changes in the guidelines for the Chatham County Guaranteed Loan Program for Small Businesses

Commissioner Pollard moved to approve the recommended changes in the guidelines of the Chatham County Guaranteed Loan Program for Small Businesses, a copy attached hereto and by reference made a part hereof. Commissioner Wilson seconded the motion. The motion carried five (5) to zero (0).

#### **EXTENSION SERVICE**

**Grant Acceptance from United Way:** Consideration of \$30,000 grant acceptance from United Way of Chatham County to fund an interpreter/volunteer coordinator to provide and coordinate translating and transportation services for United Way agencies working with the Latino Community, Budget Amendment #24

Commissioner Pollard moved to accept grant funds from United Way of Chatham County to fund an interpreter/volunteer coordinator working with the Latio Community on a contractual basis and approval of **Budget Amendment #24**. Commissioner Wilson seconded the motion. The motion carried five (5) to zero (0).

# **BOARD OF COMMISSIONERS' MATTERS**

**Workshop Dates for Budget Review:** Consideration of dates for Commissioners to hold Workshop for Budget Review

The Manager explained that one of the purposes of developing the Preliminary Needs Assessment was to get as much direction and feedback from the Commissioners to the Staff so that they could have guidance in preparing the budget. Once this is done, it will be turned around and given to the Department Heads with

instructions as to what the Commissioners are looking for with regard to budget preparation. He stated that he needs to know if the Board is interested in any type of presentations from Department or Agency Heads to be called in to the Manager's Office by Wednesday, February 15, 1995.

Commissioner Grimes moved to set a special meeting for budget deliberations on February 22, 1995 from 9:00 am to 4:00 pm and February 23, 1995 from 2:00 pm to 5:00 pm., if needed. Commissioner Wilson seconded the motion. The motion carried five (5) to zero (0).

**Family Violence and Rape Crisis:** Consideration of a request for a special allocation for shelter operating expenses for the 1994-95 fiscal year

The County Manager stated that this item had appeared before the Board some months ago and he now feels that their financial position has somewhat changed. He stated that it appears that their absolute deficit is approximately \$6,541.00, and that they are now requesting from the County \$13, 741.00 which includes the \$6,541.00 shortfall, the extra amount to be used for the refilling of one counseling position.

Jo Sanders, stated that the amount needed to stay afloat without refilling the counseling position is \$6,541.00; that not having the counseling position will have a drastic impact on their service delivery; that violence in the home is the beginning of the picture; that an investment in their services really impacts the quality of life in the whole

community and that it is well known that violence in the home spreads over into the community and is one of the major causes of violence in the community.

Commissioner Grimes moved to authorize the remainder of the County payments to the agency. Commissioner Wilson seconded the motion. The motion carried five (5) to zero (0).

**Trapping of Foxes:** Consideration of a local bill to allow the trapping of foxes

Commissioner Wilson moved to hold a public hearing on the trapping of foxes on February 27, 1995 to begin at 7:00 pm. and the public hearing on rezoning the University

Lake watershed to begin at 7:30 pm. Commissioner Dunlap seconded the motion. The motion carried five (5) to zero (0).

# **CLOSED SESSION**

Commissioner Wilson moved to go out of Regular Session and into Closed Session for the purpose of negotiating price for the acquisition of real property.

Commissioner Dunlap asked to amend the motion to include litigation. Commissioner Pollard seconded the motion. The motion carried five (5) to zero (0).

After discussion of the first item, Commissioner Grimes asked to be excused from the remainder of the meeting due to a scheduling conflict.

Commissioner Pollard moved to excuse Commissioner Grimes from the meeting. Commissioner Wilson seconded the motion. The motion carried five (5) to zero (0).

Commissioner Dunlap moved to go out of Closed Session and into Regular Session. Commissioner

Pollard seconded the motion. The motion carried four (4) to zero (0).

Commissioner Dunlap moved to authorize the staff to negotiate for purchase the secondary site for the proposed Crutchfields convenience center site, provided that mutually agreeable terms could be reached. Commissioner Pollard seconded the motion. The motion carried four (4) to zero (0).

# **BOARDS AND COMMITTEES**

**Appointment of Commissioners to all Boards and Committees:** Consideration of appointments of Commissioners to all boards and committees

Commissioner Wilson moved to appoint Commissioner Pollard to the Board of Health. Commissioner Dunlap seconded the motion. The motion carried four (4) to zero (0).

Commissioner Pollard moved to appoint Commissioner Wilson to the Economic Development Board. Commissioner Dunlap seconded the motion. The motion carried four (4) to zero (0).

Commissioner Dunlap asked to be excused from the remainder of the meeting.

Commissioner Pollard moved to excuse Commissioner Dunlap from the remainder of the meeting. Commissioner Wilson seconded the motion. The motion carried four (4) to zero (0).

# **MANAGER'S REPORTS**

The County Manager informed the Board that he had been negotiating for someone on an interim basis for the showing of property, meeting with perspective clients,

and helping the County with some of the duties of the Development Office since Melanie O'Connell Underwood will soon be leaving.

# **COMMISSIONER'S REPORTS**

Commissioner Pollard asked about the renaming of Raymond Street.

The Manager stated that this issue would be on the February 27, 1995 agenda.

Commissioner Pollard asked how the Economic Development position is progressing.

The Manager stated that he expects the issue to come up on the next agenda. He stated that the sub-committee of the Economic Development Committee has recommended that the position be formed as a non-profit position as in much the same manner as Lee County has done.

After further discussion, it was suggested that a meeting between the Commissioners, the Economic Development Committee, and the person with whom the Mangaer is negotiating to temporarily take over the position take place. It was decided that the meeting should be held prior to the regularly scheduled Board of Commissioner's meeting at 4:30 pm on February 27, 1995.

Commissioner Holland questioned where the County stands on the redistricting issue.

The Manager explained that the County had received a draft of the legislation from Michael Crowell. He stated that it has been sent to the County Attorney for review and will be included as part of the County package to take to the legislators in March.

Commissioner Wilson questioned the issue of impact fees.

The Manager explained that he and the Planning Director are comparing the differences in impact fees to see if the one they have has weak points that need to be changed. He stated that once that is in order, consultants will probably need to be hired to develop the data, the rationale, and justification for the fees. He stated that this will be a mammoth undertaking.
