The meeting began with Sally Kost, Co-Chair, welcoming the group. Task force members and staff of participating jurisdictions in attendance introduced themselves. Sally Kost gave an overview of the last meeting minutes, briefly discussed the location of the next meeting and approved the current agenda. The following are summaries of items discussed.

1. General Overview of Current Land Use Plan and Land Use Decision

Craig Benedict, Orange County Planning Director, presented their conservation plan and discussed air quality and watershed issues. He explained the conservation plan is checked annually to see what has been implemented. Maps were shown indicating incorporated areas, extraterritorial jurisdictions, and the Chapel Hill/Carrboro joint planning area (since 1987). It was further explained that the Chapel Hill /Carrboro joint planning area has an agreement with a 20 year life span. Public water and sewer service boundaries, density limits, and zoning in areas along the Haw River were also discussed. The current joint planning agreement with Hillsborough phase II is about 5-7 years out with water/sewer treatment plant. The basic agreement with town is amended

every 10-15 years. The City of Mebane annexations were also discussed and it was suggested that Mebane and Durham may need to be invited to attend future meetings.

Jason Sullivan, Chatham County Acting Planning Director, presented an overview of land use, regulations, and decision making in the county and a handout was provided.

2. <u>Explanation and Update of Development Approved in Southern Orange County and Northern Chatham County</u>

JB Culpepper, Chapel Hill Planning Director, briefly touched on a 26 unit subdivision which was approved in 2008 and planning with Durham.

Roy Williford, Carrboro Planning Director, referred to the handout for development in Carrboro.

Craig Benedict, Orange County Planning Director, discussed a subdivision that borders Chatham County that has stubbed out roads and interconnectivity issues that were brought up as part of a subdivision request.

Jason Sullivan, Chatham County Acting Planning Director, spoke about various projects in the northeastern portion of Chatham County along the US 15-501 corridor.
