# **HUMAN SERVICE PROGRAMS**

Commissioner Phillips moved, seconded by Commissioner Pollard, to approve the Human Service Programs budget as proposed by the County Manager, with the exception of reducing funding to Child Care Networks by \$1,507 and delaying action on the budgets for JOCCA and Wake County Opportunities in order to gain more information. The motion carried four (4) to zero (0).

#### ORANGE-PERSON-CHATHAM MENTAL HEALTH AREA PROGRAM

Commissioner Pollard moved, seconded by Commissioner Phillips, to approve the Orange-Person-Chatham Mental Health Area Program budget as proposed by the County Manager. The motion carried four (4) to zero (0).

#### **CENTRAL PERMITTING**

Commissioner Pollard moved, seconded by Commissioner Outz, to approve the Central Permitting division budget as proposed by the County Manager. The motion carried four (4) to zero (0).

#### ECONOMIC DEVELOPMENT CORPORATION

Commissioner Phillips moved, seconded by Commissioner Pollard, to approve the Economic Development Corporation budget as proposed by the County Manager. The motion carried four (4) to zero (0).

#### **PUBLIC WORKS TRANSFERS**

Commissioner Pollard moved, seconded by Commissioner Outz, to approve the Public Works Transfers budget as proposed by the County Manager. The motion carried four (4) to zero (0). The Board also directed staff to send a letter to the Waste Management staff commending them for their work to reduce the General Fund transfer.

#### **EMERGENCY MEDICAL SERVICES**

Commissioner Pollard moved, seconded by Commissioner Outz, to: 1) approve the Emergency Medical Services division budget as proposed by the County Manager; 2) withhold East Chatham Rescue's funding until the County Finance Officer and Board are satisfied that the agency has a clean financial report; 3) require all rescue squads to submit an audit of FY 1998-99 by December 31, 1999; and 4) if no audit is received by the prescribed deadline, funding of the effected rescue squads will be discontinued. The motion carried four (4) to zero (0).

#### **EMERGENCY OPEATIONS**

Commissioner Pollard moved, seconded by Commissioner Outz, to approve the Emergency Operations division budget as proposed by the County Manager. The motion carried four (4) to zero (0).

#### FIRE MARSHAL

Commissioner Phillips moved, seconded by Commissioner Pollard, to approve the Fire Marshal's Office division budget as proposed by the County Manager. The motion carried four (4) to zero (0).

# **FEE INCREASES**

Commissioner Phillips moved, seconded by Commissioner Pollard, to approve the fee increases proposed by the County Manager on Pages 15 through 18 of the Recommended Budget. The motion carried four (4) to zero (0). Pages 15-18 are attached hereto and by reference made a part hereof.

# EMPLOYEE PAY AND BENEFITS PACKAGE

Commissioner Phillips moved, seconded by Commissioner Outz, to approve the employee pay and benefits package as proposed by the County Manager. The motion carried four (4) to zero (0).
