# MINUTES CHATHAM COUNTY BOARD OF COMMISSIONERS REGULAR MEETING, AUGUST 16, 1999

The Board of Commissioners ("the Board") of the County of Chatham, North Carolina, met in the District Courtroom, located in Pittsboro, North Carolina, at 7:00 P.M. on August 16, 1999.

Present: Chair Rick Givens; Vice Chair Uva Holland;

Commissioners Margaret Pollard, Carl Outz, and Gary Phillips; County Manager, Charlie Horne; County Attorney, Robert L. Gunn; Assistant Manager, Reneé Dickson; Finance Officer, Vicki McConnell; and Clerk to the Board, Sandra B. Lee

The meeting was called to order by the Chairman at 7:15 PM.

# **AGENDA**

The Chairman asked if there were additions, deletions or corrections to the Agenda.

The County Manager asked that Item #7 Department of Social Services Contract for transportation services be deferred until the next meeting and Item #9 Presentation of the Distinguished Financial Award be deferred until a later date.

He asked that consideration of a bid acceptance for a backhoe for the Utilities Division be added to the Agenda as Item #9; that revision to the subordination agreement that Counsel will discuss as Item #9A; and that a contract for the courthouse clock be added as Item #9B.

Commissioner Outz asked that Item #8, consideration of a request for approval to accept grant funds in the amount of \$20,000 for the Cooperative Extension Service be moved to the Regular Agenda.

Commissioner Phillips asked that Item #6, Chatham County Design Guidelines be moved to the Regular Agenda for discussion.

Commissioner Outz moved, seconded by Commissioner Phillips, to approve the Agenda with the noted requests. The motion carried five (5) to zero (0).

#### END OF CONSENT AGENDA

**Chatham County Design Guidelines:** Consideration of Chatham County Design Guidelines for information purposes only

Commissioner Phillips commended the committee who assembled the Chatham County Design Guidelines. He stated that he feels that it is a good step in the right direction; that he particularly appreciates the parking guidelines and consolidating of landscaping buffering and screening of commercial facilities; and that he is particularly interested in site-mapping and site-inventory so that valuable things are preserved whenever they are used for large projects.

A copy of the Chatham County Design Guidelines are attached hereto and by reference made a part hereof.

**Grant Acceptance for Cooperative Extension Service:** Consideration of a request for approval to accept grant funds in the amount of \$20,000 to be used by the Chatham County Cooperative Extension Service to conduct a 4-H Career Jamm Program

Commissioner Pollard stated that according to the agenda abstract, a cash match was required for young people over 16 years of age, yet it was designed for much younger children. She asked if the staff understands that there will be no children in that age category.

Staff stated that it was their understanding that the Cooperative Extension Service was not asking for a match of County funds, but that there are no children over 12 years of age.

Commissioner Holland moved, seconded by Commissioner Pollard, to accept grant funds in the amount of \$20,000 to be used by the Chatham County Cooperative Extension Service to conduct a 4-H Career Jamm Program. The motion carried five (5) to zero (0).

# **PUBLIC INPUT SESSION**

**Barbara Oslund**, 114 Holly Glenn Road, Pittsboro, NC, stated that she had signed up to speak with regard to the Recreation Master Plan. She stated that because this item was placed on the agenda and that she realized she would not be able to speak on it, she wanted to say that she was in favor of the plan.

**Bid Acceptance for Backhoe for Utilities Division:** Consideration of a request for approval of a bid award to Gregory Poole for a backhoe for the Utilities Division

Commissioner Phillips moved, seconded by Commissioner Pollard, to approve the bid award to Gregory Poole in the amount of \$68,898.00 for a backhoe for the Utilities Division. The motion carried five (5) to zero (0).

**Community Development Block Grant Bid Awards:** Consideration of a request to award bids for the Community Development Block Grant, FY 97 project

demolition of the four (4) substandard housing units to R & W Demolishing in the amount of \$18,000.00 and to award the bid for the installation of three (3) septic systems to Randy Cheek in the amount of \$14,700. The motion carried five (5) to zero (0).

Commissioner Pollard asked that the guidelines for future Community Development Block Grant Awards be given to the Board for study.

**Set Date for Public Hearing on University Lake** Consideration of a request to set a date on which to hold a public hearing to receive public comments on the rezoning of the University Lake Watershed

Commissioner Phillips moved, seconded by Commissioner Outz, to hold a public hearing on September 20, 1999 to receive public comments on the rezoning of the University Lake Watershed. The motion carried five (5) to zero (0).

**Parks and Recreation Master Plan:** Consideration of a public presentation of 75% Parks and Recreation Master Plan

Tracy Burnett, Chatham County Recreation Director, introduced Dave Malcolm, Project Manager, who reviewed Recreation Master Plan conducted by Hayes, Seay, Mattern and Mattern (HSMM). He stated that the survey, site visits and evaluation, self-assessment survey, map workshop and 75% of the draft master plan is now complete; and that the master plan includes the following information:

**Budget Calendar for FY 2000-2001:** Consideration of a request for approval of budget calendar for FY 2000-2001

Commissioner Outz moved, seconded by Commissioner Pollard, to approve the FY 2000-2001 Budget Calendar as proposed by the staff and to include assurance that advisory boards are involved in the budget process, and that as part of the Commissioners' Retreat, ways to save the County money are explored. #### MANAGER'S REPORTS

The County Manager had no reports to present, but thanked the Board for their hard work during the afternoon work session.

#### **COMMISSIONERS' REPORTS**

#### **Environmental Health Issue:**

Commissioner Phillips stated that he had met several times with the Environmental Health Department to discuss environmental health issues; that his meeting the prior week dealt more with

visions than problems; that one thing that came up and will need to be addressed in the future is that of permitting septic systems; that one problem area that is a deep concern is that of permitting lots under two acres in size on which there is an inadequate repair area; that certain soils that are approved for septic will last for one or two decades; that there is one area in northern Chatham that has a septic failure rate of approximately 35-45%; that Environment Health is very concerned about this issue; that the only option they have is the very expensive option of basically taking out all of the soil and replacing it with all new soil and building an entirely new system; that this is hard for homeowners to take; that they have asked that the Board seriously consider restricting subdivisions on well and septic to no less than two acres in size which will assure that if the septic area fails, there will still be enough area left for a repair area in the future without having to do some of the extraordinary things which are having to be done now.

#### East Chatham/North Chatham Rescue Squad:

Commissioner Outz stated that he still receives calls with regard to the East Chatham/North Chatham Rescue Squads being audited and that the SBI is looking into the missing funds.

#### **JOCCA:**

Commissioner Outz moved, seconded by Commissioner Givens, to send a letter to Federal and State Legislators to review JOCCA's audit with regard to misspent funds in the amount of approximately \$400,000.00. The motion carried three (3) to two (2) with Commissioners Pollard and Phillips dissenting. A copy of the letter is attached hereto and by reference made a part hereof.

# **Chatham County Board of Education:**

Chairman Givens voiced concern with regard to the progression of negotiations by the Chatham County Board of Education for land acquisition for the proposed school in North Chatham. He asked that a letter be sent detailing the displeasure of the Board of Commissioners with regard to this issue.

Commissioner Pollard moved, seconded by Commissioner Outz, to sent a letter to each member of the Chatham County Board of Education and School Superintendent, Dr. Larry Mabe, detailing the displeasure of the Board of Commissioners with regard to their proceeding with plans for land acquisition without the involvement and the cooperation of the Board of Commissioners. The motion carried five (5) to zero (0). A copy of the letter is attached hereto and by reference made a part hereof.

#### **Immigration and Naturalization Service (INS):**

Commissioner Givens asked for support from the Board requesting that immigration enforcement officials review current enforcement actions in Chatham County and outline a plan for future enforcement with regard to illegal immigrants.

Commissioner Givens moved, seconded by Commissioner Pollard, to send a letter to State and Federal representatives asking for increased enforcement of illegal immigrants in Chatham County by the Immigration and Naturalization Service. The motion carried five (5) to zero (0). A copy of the letter is attached hereto and by reference made a part hereof.
