**Roland Rodgers**, 8705 Siler City-Snow Camp Road, Snow Camp, NC, asked for consideration in bringing water to his area of the County. He stated the water is full of iron where he lives and is unsuited for drinking, cooking, and washing clothes. #### **NC Environmental Management Commission Addresses:**

### **Courthouse Annex Add-On:**

Commissioner Outz asked if Kurt Lent, Architect, had checked into the courthouse annex add-on.

The County Manager stated that this has been done and is part of the work session to be held on September 20, 1999.

#### **Monitored Landfill Well Status:**

Commissioner Outz asked if the NC State Agriculture Engineering Department had been consulted with regard to the monitored well status at the landfill.

The County Manager explained that the NC State Agriculture Engineering Department has

been consulted, but that they deal primarily with lagoon issues and not landfills and not movement of leachate from landfill into ground water tables.

## **Silk Hope Old Farm Days:**

Commissioner Phillips stated that everyone had a great weekend at the Silk Hope Old Farm Days; that there was a greater than ever turnout on Saturday; that there were more tractors and old cars in attendance than usual; and that everyone was very appreciative of the rain that fell during that time.
