# MINUTES CHATHAM COUNTY BOARD OF COMMISSIONERS REGULAR MEETING, DECEMBER 06, 1999

The Board of Commissioners ("the Board") of the County of Chatham, North Carolina, met in regular session in the District Courtroom, located in, Pittsboro, North Carolina, at 7:00 PM on December 06, 1999.

Present: Commissioners Margaret Pollard, Uva Holland, Carl Outz, Gary Phillips and Rick Givens; County Manager, Charlie Horne; County Attorney, Robert L. Gunn; Assistant County Manager, Renee Dickson; Finance Officer, Vicki McConnell; and Clerk to the Board, Sandra B. Lee

The meeting was called to order by the Chairman at 7:07 PM.

# **ORGANIZATION OF THE BOARD**

#### **Chairman**

County Attorney, Robert Gunn, presided over the organization of the Board. He opened the floor for nominations for Chairman of the Chatham County Board of Commissioners.

Commissioner Outz nominated Commissioner Givens as Chairman of the Chatham County Board of Commissioners. Commissioner Holland seconded the motion.

Hearing no other nominations, the presiding officer called for a vote for Commissioner Givens. The motion carried five (5) to zero (0).

### Vice Chairman

The floor was opened for nominations for the position of Vice Chair. Chairman Givens nominated Commissioner Holland for the office of Vice Chair. Commissioner Outz seconded the motion.

Hearing no other nominations, the Chairman called for a vote for Commissioner Holland. The motion carried five (5) to zero (0).

Commissioner Givens moved, seconded by Commissioner Holland, to reappoint Robert L. Gunn as the County Attorney. The motion carried five (5) to zero (0).

## **PUBLIC INPUT SESSION**

**Jean H. Hudson**, PO Box 641, Pittsboro, NC, stated that she had a problem with the zoning of approximately one hundred acres of her property on both sides of Mt. Gilead Church Road which has been zoned as legal but non-conforming. She asked that the zoning maps be corrected to show that the area is zoned for industrial, commercial, retail and not agricultural.

### PLANNING AND ZONING

**Preliminary Design Approval of "Deep River Bluffs":** Consideration of a request by Dave Heidiger for White Pine Properties for preliminary design approval of "**Deep River Bluffs"**, consisting of 11 lots on 83.73 acres, off SR #1956 (East Gargus Road), in Oakland Township

Commissioner Pollard moved, seconded by Commissioner Holland, to accept the Planning Department and Planning Board recommendation and the preliminary plat be approved as submitted with approval of the proposed road name Millstone Road (Ext.), with the following two (2) conditions:

- 1) Floodable area shall be designated on all subdivision lots on the final plat. It is recommended that floodable areas also be designated on the non-subdivision lots.
- 2) The private easement from SR #1956 to the subject property shall be upgraded to the County private road standards.

The motion carried five (5) to zero (0).

# **BOARD OF ADJUSTMENT**

Commissioner Holland moved, seconded by Commissioner Pollard, to recess as the Board of Commissioners. The motion carried five (5) to zero (0).

Commissioner Holland moved, seconded by Commissioner Outz, to convene as the Board of Adjustment. The motion carried five (5) to zero (0).

The Chairman administered the oath to those in attendance who wished to make public comments.

**Board of Adjustment Requests:** Consideration of two exceptions from the Chatham County Educational Facilities Impact Fee Ordinance

Commissioner Givens moved, seconded by Commissioner Pollard, to accept the Planning Department recommendation and deny the request for exemption from the Chatham County Educational Facilities Impact Fee Ordinance for Mr. Joe Burnette. The motion carried five (5) to zero (0).

Commissioner Phillips moved, seconded by Commissioner Outz, to accept the Planning Department recommendation and deny the request for exemption from the Chatham County Educational Facilities Impact Fee Ordinance for Ms. Jean H. Hudson. The motion carried five (5) to zero (0).

The County Attorney asked that the record show that he will prepare an order which includes Findings of Fact and Conclusions of Law for the Chairman's signature to be executed at the next Board of Commissioner's meeting on January 3, 2000.
