Safe Start Presentation:

Jenny Megginson, Smart Start Director, explained that that "Safe Start" deals with violence prevention and intervention in early childhood. She stated that the funding must come through the County because it is a federal grant; that the grantor also wants the County to serve in a lead agency capacity through the Board of Commissioners; that there is not a required match amount; that she is requesting the Board approve an increased amount of grant funds; that the Board has already approved \$250,000; that they must apply for \$670,000; that \$250,000 will be for planning and \$420,000 for initial implementation; and that they will be offering \$670,000 annually for five years. Ms. Megginson stated that the purpose of the meeting was to clarify the relationship between Smart Start and the Board of Commissioners. She asked the Board to approve increased grant funds and proposed structure.

After considerable discussion, Commissioner Pollard moved, seconded by Commissioner Holland, to approve the Safe Start Organizational Chart and acceptance of the Board of Commissioner's oversight responsibility, provided there is oversight for implementation and approval of application for increased funding. The motion carried four (4) to one (1) with Commissioner Outz opposing.
