CENTRAL CAROLINA COMMUNITY COLLEGE

Commissioner Grimes moved, seconded by Commissioner Dunlap, to approve the Manager's recommendation for funding of Central Carolina Community College and to flag the \$38,499 recommended to cover loss of plant maintenance funds from the state and the \$13,611 for increased utility costs so that if these funds are replaced by the state, the County will not appropriate these funds to Central Carolina Community College (CCCC).
