## Resolution of the Chatham County Board of Commissioners

### Honoring the Service of Andrew Siegner, III

Whereas, Andrew Siegner began employment with the Chatham County Public Health Department as an Environmental Health Specialist on January 4, 1993; and

Whereas, Andrew Siegner has consistently carried out his responsibilities in applying state and local laws to protect the health of Chatham County residents fairly and consistently during his career, and

Whereas, Andrew Siegner was promoted to Onsite Wastewater Program Coordinator in 2003; and

Whereas, Andrew Siegner developed the first Chatham County Onsite Wastewater Contractor Workshop which has become a successful annual event for providing education and networking to contractors and vendors, and which is recognized as a model workshop across North Carolina; and

Whereas, Andrew Siegner supported the development of additional training workshops for well contractors, homeowners with wells and septic systems and subsurface operators, and

Whereas, Andrew Siegner was instrumental in the development of standards for a pre-treatment drip irrigation wastewater system which is now an option for property that previously could not be permitted for conventional septic systems, resulting in many landowners being able to develop property and build homes, and

Whereas, Andrew Siegner was promoted to the position of Environmental Health Director in 2007, and

Whereas, Andrew Siegner provided expert advice to the Chatham County Board of Health in the revision of the Well Construction Rules, and sound advice to the Board of Health on the impact of the land application of biosolids to the health and environment, and

Whereas, Andrew Siegner provided leadership in educating Chatham County residents about preventing exposure to tick borne illnesses through innovative educational approaches, and

Whereas, Andrew Siegner has been instrumental in the study of childhood exposure to environmental lead sources and the subsequent development of a program to reduce exposure to lead by Chatham County children, and

Whereas, Andrew Siegner has been known for his courteous, customer-oriented, helpful and collaborative approach to all interactions with the public, his coworkers, and state and local officials, and

Whereas, Andrew Siegner was recognized as 2010 Supervisor of the Year by the North Carolina Environmental Health Supervisors Association for his contribution and leadership in the field of Environmental Health .

**NOW, THEREFORE, BE IT RESOLVED** that the Chatham County Board of Commissioners honors this outstanding public servant and wishes him a well-deserved, happy, and fulfilling retirement.
