TAX DEPARTMENT

Schedule of Values:

Kim Horton, Chatham County Tax Administrator, reviewed the Schedule of Values for the 2001 revaluation. She stated that General Statues 105-317 (b) (1) states, "In preparation for each revaluation of real property, it shall be the duty of the assessor to see that uniform schedules of values, standards, and rules to be used in appraising real property at its true value and at its present-use value are prepared and are sufficiently detailed to enable those making appraisals to adhere to them in appraising real property."; that she will be presenting the Schedule of Values for the 2001 revaluation at the Commissioners' meeting on August 21, 2000; that copies of the schedules will be placed in the County Manager's Office and the Tax Office; that a notice will be issued in the local newspaper stating that the proposed schedules to be used in appraising real property in the County have been submitted to the Board and are available for inspection; that a public meeting will be held on September 5, 2000 with the proposed adoption scheduled for September 18, 2000; that the Schedule of Values contains all the rates and factors that are considered when appraising real property; that there is also a value for taxing tobacco allotments and that the allotments shall be taxed.

Ms. Horton introduced the members of her staff to the Board and Ron McArthy who is the consultant for the first in-house revaluation.

Mr. Tucker was asked to get a Request for Proposals (RFP) with scope of services for consultants to create options for consideration.
