MINUTES CHATHAM COUNTY BOARD OF COMMISSIONERS **REGULAR MEETING APRIL 17, 2000**

The Board of Commissioners ("the Board") of the County of Chatham, North Carolina, met in the District Courtroom, located in Pittsboro, North Carolina, at 7:00 PM on April 17, 2000.

The meeting was called to order by the Chairman at 7:01 PM.

AGENDA

PUBLIC INPUT SESSION

Patti Dukes, 4668 Moncure-Pittsboro Road, Moncure, NC, stated that as a resident of Moncure, she is concerned with regard to the CSX-3M rail proposal; that she is a resident and landowner of Moncure that would be affected by the proposed rail; that it is currently a quiet community and the noise pollution level would be raised by having this rail; that there is a lot of wildlife that would be displaced; and that there is no guarantee from CSX that only 3M would be using this line. She further stated that she is personally impacted by this proposal; that she has had training in organic farming and intended to begin organic farming and be part of the farm tour; that placement of the rail line would cause her to not be eligible for organic certification due to toxins released from the rail and cargo being hauled; and that her pottery studio would also be compromised due to its close proximity to the proposed rail line, resulting in loss of product from the continual shaking of the ground. She stated that she had spoken with George Sherrill from the NC Department of Commerce, and his recommendation was to ask the Board to retract the grant for 3M

Jerry Markatos, 800 Rock Rest Road, Pittsboro, NC, Chairman of the Chatham County Democratic Party, reviewed resolutions that were presented by different Chatham County Precincts and approved at the Democratic Party Convention held Saturday, April 15, 2000 in the Chatham County Superior Courtroom. He asked for endorsement of the resolutions by the Board of Commissioners.

Resolution Honoring Service of James L. Alston: Consideration of a request to approve Resolution Honoring the Service of James L. Alston on the Occasion of his Retirement from the Chatham County Public Works Department

Carolyn Chandre, Human Resources Manager, read the Resolution Honoring the Service of James L. Alston on the Occasion of his Retirement from the Chatham County Public Works Department.

Commissioner Pollard moved, seconded by Commissioner Holland to approve the **Resolution** #2000-14 Honoring the Service of James L. Alston on the Occasion of His Retirement from the Chatham County Public Works Department. The motion carried five (5) to zero (0). CHATHAM EDUCATION FOUNDATION

Phillip Cates, Executive Director of the Chatham Education Foundation, stated that the Chatham Education Foundation has been part of the community since 1992; that it is the only non-profit, independent, community-based organization dedicated to improving public schools; that over the last few years, the Foundation has allocated almost \$400,000 to programs in the schools, and that it is only a start. He further stated that the Chatham County Schools are in deterioration; that an independent survey was conducted that showed that the teacher turnover rate last year was 14%; that it is estimated to reach 18% by the end of the year; and that Chatham County teachers were paid 40-55% less than surrounding counties. He invited the Commissioners to attend the Consultation with Teachers Meeting on April 19, 2000 at 6:30pm at Best Foods Cafeteria in Siler City.

PLANNING AND ZONING

Sketch Design Approval:

Sketch Design Approval – "Governors Village Office": Consideration of a request by Duke Weeks Realty, LLP for subdivision sketch design approval for "**Governors Village Office**", consisting of three (3) non-residential lots on 5.7 acres, off SR #1008 [Farrington Road], in Williams Township

Commissioner Outz moved, seconded by Commissioner Pollard, to accept the Planning Department and Planning Board recommendation and grant sketch design approval as submitted. The motion carried five (5) to zero (0).

Sketch Design Approval – "Thompson Creek, Phase Two": Consideration of a request by Chatham Development Corporation for subdivision sketch design approval of "**Thompson Creek, Phase Two**", consisting of 12 lots on 57.9 acres off SR #1741 [Thompson Road], in New Hope Township

Commissioner Phillips moved, seconded by Commissioner Outz, to approve the request for subdivision sketch design approval with the following condition:

1. Lots within Phase One and Two be consecutively numbered.

Final Plat Approval:

Subdivision Variance Request and Final Approval - "Deep River Bluffs, Phase II"

Consideration of a request by Dave Heidiger for White Pines Properties, for subdivision variance and final approval for "**Deep River Bluffs, Phase II**", consisting of four (4) subdivision lots and one (1) unapproved lot, on 27.3 acres, off SR #1956 (East Gargus Road), in Oakland Township

Commissioner Phillips moved, seconded by Commissioner Pollard, to approve the Planning Department and Planning Board recommendation and grant approval of the variance request due to the existing topography of the land, the NCDOT requirements for public roads and the relatively small deviation from the requirements and final approval of Deep River Bluffs, Phase II with the following condition:

1. The plat not be recorded until the mylar is revised to read 100' Water Hazard Buffer.

Zoning and Ordinance Amendment:

Conditional Use District with Conditional Use Permit for Medical Clinic: Consideration of a request by J. Lowell Williams for an Office and Institutional Conditional Use District with a Conditional Use Permit for a medical (dental) clinic, on 3.24 acres, off US #15-501 North, in Baldwin Township

Commissioner Pollard moved, seconded by Commissioner Outz, to accept the Planning Department and Planning Board recommendation and approve the request as submitted with the following conditions:

- 1. A building permit for the dental office be obtained prior to December 31, 2000 and remain valid or the conditional use permit becomes null and void.
- 2. The general layout and design and landscaping shall be as submitted and shown on the site plan and landscape plans for Dr. J. Lowell Williams, dental office, dated 02/11/00.
- 3. The lighting plan be submitted to the Planning Department for review and approval before the building permit is issued. Appeals from the Planning Department decision shall go to the Planning Board for review.

2000-2001 Communication Tower Plan: Consideration of a request by Sprint SBA for a search area south of Gulf along US #421 for a 300 foot tall lattice tower

Commissioner Phillips moved, seconded by Commissioner Outz, to accept the Planning Department and Planning Board recommendation that the request by Sprint SBA for a search area south of Gulf along US #421 for a 300 foot tall lattice tower be approved as submitted. The motion carried five (5) to zero (0).

Sketch, Preliminary and Final Approval:

Subdivision Sketch, Preliminary, and Final Approval for "James Lowell Williams Subdivision": Consideration of a request by Dr. James Lowell Williams for subdivision sketch, preliminary, and final approval for "**James Lowell Williams Subdivision"**, consisting of one (1) non-residential lot on 2.94 acres, off US #15-501 North, in Baldwin Township

Commissioner Outz moved, seconded by Commissioner Holland, to accept the Planning Department and Planning Board recommendation and grant sketch, preliminary, and final approval of Survey for James Lowell Williams Subdivision with the following condition:

1. The plat not be recorded until the vicinity map is revised to show the 2.94 acre tract location.

The motion carried five (5) to zero (0).

TAX DEPARTMENT

Amended Business Personal Property Listings: Consideration of a request by Turner Hargrove to accept amended Business Personal Property Listings for tax years prior to 1999

After considerable discussion regarding the removal of Hargrove equipment sold in the early 1990's due to a business reorganization, comments that Mr. Hargrove furnish the Tax Department with the purchaser's names of said equipment for tax years 1996-1999, a discussion regarding parts and engines which have prolonged the life of equipment, and comments that other equipment be removed from the 1999 tax listing, Commissioner Outz moved, seconded by Commissioner Pollard, to table the matter for discussion at a later date. The motion carried five (5) to zero (0).

It was noted that Chairman Givens, the Tax Administrator, and Mr. Hargrove are to meet at a mutually agreeable time in the near future to discuss this issue.

Water Lines in Asbury Community:

Commissioner Pollard asked about the status of the water lines on the Old Sanford Road in the Asbury Community with regard to the 3M Company.

The County Manager stated that the project is being worked on but that there is no additional information available on it at this time.

Sheriff's Department Satellite Office in the New Fire Department:

Commissioner Holland stated that citizens in her area had approached her about the possibility of setting up a satellite law enforcement station at the new fire department

Quiz Bowls:

Commissioner Phillips informed the Board of the quiz bowls that are in the process of taking place at Jordan Matthews High School on Tuesday, April 18, 2000.

Cape Fear Water Quality:

He also informed the Board that the North Carolina Division of Water Quality (DWQ) has prepared a draft of the Cape Fear River Basinwide Water Quality Plan as a tool to help restore and protect water quality in the Cape Fear River River basin and stated that public meetings are held to answer questions about the draft plan and to obtain comments on the plan. The next meeting will be held on Tuesday, April 25, 2000, 7:00 PM, in the Chatham County Agricultural Building.

Correction to February 21, 2000 Board of Commissioners' Minutes:

It was brought to the Clerk's attention that the February 21, 2000 Board of Commissioners' minutes show approval of "Deep River Bluffs, Phase I". The original request was for approval of 7 lots. The Planning Board and Planning Department recommended approval of 6 lots. Commissioner Phillips moved correction of the February 21, 2000 minutes to show that only 6 lots were approved. Commissioner Holland seconded the motion. The motion was approved by the Board by a vote of five (5) to zero (0).

Final Plat Approval of "Deep River Bluffs, Phase I": Consideration of approval of a request by Dave Heidiger for White Pines Properties for final plat approval of **Deep River Bluffs, Phase I**, consisting of 6 lots on 30.4 acres, off SR #1956 (East Gargus Road), in Oakland Township

Commissioner Phillips moved, seconded by Commissioner Holland, to accept the Planning Department and Planning Board recommendation and grant final plat approval to include six lots consisting of Tract #1 and Lots #3, 4, 5, 6, and 7 with the following condition:
