MINUTES CHATHAM COUNTY BOARD OF COMMISSIONERS WORK SESSION, APRIL 17, 2000

The Board of Commissioners ("the Board") of the County of Chatham, North Carolina, met in the Henry H. Dunlap, Jr. Building, Classroom, located in Pittsboro, North Carolina, at 4:00 PM on April 17, 2000.

Well Ordinance:

A date was set for May 15, 2000 to hold a public hearing on the well ordinance. This is to be a joint meeting with the Chatham County Board of Health.

North Carolina Rural Communities Action Plan:

Scott Edelman and Sharon LaPalme of NCRCAP gave a brief presentation on the Community Development Block Grant (CDBG) Infrastructure Grant Program as a potential funding source for the Stockyard Road sewer line extension. Timing of the CDBG Economic Development award for the 3 M project and how it would determine the maximum amount of the CDBG Infrastructure grant funds for which the County could apply was discussed. NCRCAP also explained that two public hearings would be required, one each at the Board of Commissioners' meetings on May 1st and May 15th.

Commissioner Pollard moved, seconded by Commissioner Holland, that the Board pursue the CDBG Infrastructure grant funds for the Stockyard Road project. The motion carried five (5) to zero (0).

The Board also reaffirmed their commitment to provide a local match of funds, totaling 10% of the grant not to exceed \$102,000.00, which was approved at their November 15, 1999 Board of Commissioners' meeting.
