The meeting was called to order by the Chairman at 4:05 PM.

Risk/Insurance Bid:

Commissioner Atwater moved, seconded by Commissioner Givens, to authorize the switch in general liability insurance companies from the NC County Commissioner's Association to St. Paul's Insurance Company, effective July 1, 2001, attached hereto and by reference made a part hereof. The motion carried five (5) to zero (0).

Industrial Facilities Financing Authority Appointments:

County Attorney, Bob Gunn, explained that as set forth in the General Statutes, tax-free revenue bonds can be issued; that the authority's name and signature are on the bond, but are not liable to pay except from revenue they get from the bonds; that the authority will not have anything to do after bonds are issued; that the bonds will favorably finance Townsend's improvements in pollution control; that the bonds are tax-free; that the project will come before the Board for approval; that afterwards, the authority does everything else; that the County is not responsible for repayment of the bonds; that the General Statutes prohibit the County from expending any funds; that there will be no cost to the County; that the State has an allocation on the amount limit that can be issued; and that local government keeps account of it.

Chairman Phillips moved, seconded by Commissioner Givens, to approve the reappointments of Rueben Warfford, PO Box 724, Pittsboro, NC; Victor Aldridge, 20 Fairway Road, Siler City, NC; J. E. Booth, Route 3, Box 240, Durham, NC; J. Wallace Jones, 1828 St. Luke Church Road, Goldston, NC and to appoint Commissioner Carl Outz, to the Industrial Facilities Financing Authority for six-year terms. The motion carried five (5) to zero (0).
