- 1. Purpose and Agenda for today's meeting
- 2 Faythe Canson Clark called the meeting to order and thanked everyone for attending.
- 3 2. Public Comment
- 4 Rachel Hoff expressed support for the PX bus route as a resident of the East side of Pittsboro. She
- 5 also inquired about the status of the Pittsboro Highway Transportation Plan regarding the proposed
- 6 15-501 bypass options. Brendan Merithew clarified that NCDOT and Pittsboro will hold a public
- 7 meeting on the proposed plan on May 10th from 5-8pm at CCCC.

Action Items

- 8 3. Approval of Minutes from February 22, 2011 Regular Meeting
- 9 Ms. Clark suggested one edit to correct Vice Chair from Claire Kane to Philip Bors. Philip Bors
- 10 suggested adding "Durham Chapel Hill Carrboro Metropolitan Planning Organization" on Line 43.
- 11 Claire Kane moved to approve the meeting minutes with the two corrections. Dale Chodorow
- 12 seconded the motion. The motion to approve the minutes was approved with no dissent.

13 Information & Discussion

- 14 4. Discussion of the Chatham County Comprehensive Transportation Plan, by Brendan
- 15 Merithew, NC DOT Transportation Planning Branch
- 16 Mr. Merithew and Scott Walston took questions from the TAB regarding the Comprehensive
- 17 Transportation Plan (CTP) process and asked about the TAB's preference for its role. The TAB
- 18 agreed to use the standing membership as the CTP committee rather than creating a separate
- 19 subcommittee. The process would still be open for public input and would take place at regularly
- scheduled TAB meetings, unless additional meetings become necessary. The process is expected to
- 21 take 18 months and will include a public survey, community input sessions, an inventory of roads,
- visioning, report drafting and map creation.

- 23 Mr. Bors suggested that NCDOT staff review the TAB Strategic Plan since the group has already
- developed a transportation vision, values, and goals. Larry Cheek suggested that all local planners
- 25 be involved in the process. Ms. Kane asked about the involvement/agreement of elected officials
- regarding the CTP. Mr. Walston indicated that they will periodically present plan elements to the
- 27 County BOC and Pittsboro and Siler City commissioners for their agreement.

28 5. Discussion of Carpooling, by Mary Bastin

- 29 Mary Bastin expressed interest in the TAB doing what it can to promote ride-sharing for Chatham
- 30 County commuters; she is willing to take a lead for TAB to increase carpooling. Ms. Kane mentioned
- 31 the existence of Triangle Transit's website (www.sharetheridenc.org), which was developed to
- 32 connect area commuters who are interested in carpooling. Ms. Clark suggested that HOAs could be
- useful to promote carpooling. Amber Wagner offered that there are many options for boosting
- ride-sharing and that CTN would be willing to help explore those. Steve Spade offered that
- 35 employer based promotion of ride-sharing is the most effective method to reduce single-occupancy
- trips. Ben Howell mentioned that Triangle Transit has operated three van pools in Chatham.
- 37 Ms. Kane suggested that Triangle Transit present at the next TAB meeting and then decide the most
- appropriate action for the TAB to encourage carpooling in Chatham.
- 39 6. Presentation and Discussion of Chapel Hill Transit PX Bus Route Statistics and Alternatives,
- 40 by Steve Spade, Director of Chapel Hill Transit
- 41 Mr. Spade presented the background of the Chapel Hill Transit (CHT) System and Partnership. He
- 42 provided a history of the PX route and its ridership data. The PX route ridership has generally risen
- 43 steadily since it began in August 2009 and grew faster than comparable services in Hillsborough and
- Wake Forest, NC. Surveys indicate that 80% of PX riders reside in Chatham County and 20% of riders
- 45 live in the Pittsboro town limits.
- The future PX route is in jeopardy because the Chatham BOC recently voted to discontinue the
- 47 county's portion of match funding as of June 2011. Pittsboro has committed to maintain level
- funding for the PX route. The CHT Partners agreed to continue their grant-funded support for the
- 49 PX route until August 2011. CHT is in the process of discussing a possible future agreement with
- 50 Chatham Transit Network (CTN) to pick up two of the six daily routes between Lowe's and UNC. CTN
- can offer service at a rate of \$20/hr cheaper than CHT, so they may be able to continue the PX
- 52 service at a lower cost. CTN already provides routes from Siler City to UNC that leave later than the
- 53 PX route.

7. Follow-Up Discussion on the Strategic Plan

- 55 Mr. Bors mentioned that the presentation of an update of the TAB and Strategic Plan for the BOC
- was postponed to April 4th. Ms. Bastin suggested that TAB members should try to attend as a show
- of support. Mr. Howell mentioned that the location is not confirmed but is likely to be in Silk Hope.
- 58 8. Updates from Staff and/or the Executive Committee
- Ms. Clark updated the TAB that the Executive Committee discussed the three open positions and
- asked members to encourage interested citizens to apply.

- There were no announcements or new business.
