BAD DEBT WRITE-OFF FOR EMERGENCY MEDICAL SERVICES/HOME HEALTH

The bad debt write-off for Emergency Medical Services (EMS) in the amount of \$146,641.01 and Home Health in the amount of \$1,288.761 was discussed.

It was discussed that First Health took over EMS services in Chatham County on July 1, 1997; that the \$145,352.30 balance, although it appears to be a large amount, consisted of charges billed to patients before

the First Health takeover; that these charges have been on the County's records since July 1, 1997; that in December, 1997, the Chatham County Home Health Agency was sold to UNC; that there was a small accounts receivable balance remaining at that time; that the County was still receiving some payments until June, 2000; and that all means of collecting the past-due balance, including hiring a third-party collection, have been exhausted.

LEASE AGREEMENT WITH GOLDSTON LIBRARY
