MORATORIUM ON INDUSTRIAL NON CONFORMING USES

Keith Megginson, Chatham County Planning Director, explained the request by S. T. Wooten regarding their air permit application and the Chatham County Land Use regulations. He stated that the moratorium on the issuance of zoning and building permits for non-conforming industrial uses that involve expansions or changes, other than maintenance and repair, would be for a time period not to exceed May 31, 2002; that the purpose of the moratorium would be to allow time for consideration of revisions to the County Zoning Ordinance Section 9 concerning non-conforming situations; that the Planning board suggested that changes to non-conforming uses be reviewed and approved by the Board of Adjustment instead of in-house staff review and approval.

Commissioner Pollard moved, seconded by Commissioner Givens, to approve a moratorium on the issuance of zoning and building permits for non-conforming industrial uses that involve expansions or changes, other than maintenance and repair, for a time period not to exceed May 31, 2002. The motion carried five (5) to zero (0).
