UTILITIES FUNDS/WATER SYSTEM MASTER PLAN

- Paul Spruill, Assistant County Manager, reviewed the current financial picture of the Utility Fund and the dependency on reserves. He outlined ongoing capital needs and transmission line challenges.
- Ron Singleton, Chatham County Public Works Director, reviewed the possibility of the USDA program assisting the County with water extensions. The establishment of water districts was also discussed.

After considerable discussion, Commissioner Atwater moved, seconded by Commissioner Pollard, to ask staff to proceed with submitting Requests for Proposals (RFPs) to engineering companies in order to apply for USDA funding.

The Board asked that staff put together scenarios for connecting Chatham County water with Siler City using the following routes: Pea Ridge Road, Silk Hope–Gum Springs Road, and US Highway #64.

The Board asked that a letter be sent to the Red Gate Road property owners who signed the petition acknowledging their water concerns.

It was discussed whether to purchase a new library book mobile or install a new motor in the present vehicle which seems to be in good shape. This matter is to return to the Board at a later date.

Commissioner Givens moved, seconded by Commissioner Pollard, that there being no further business to come before the Board, the meeting be adjourned. The motion carried five (5) to zero, and the meeting was adjourned at 1:00 PM.
