NUISANCE ORDINANCE REVIEW

Specifics of noise ordinances were discussed.

Commissioner Atwater asked that staff corroborate with the Health Department to prepare a potential draft of a revised noise ordinance.

The County Manager is to arrange to have a noise meter so that the Board can listen to 60/70 decibel

Commissioner Pollard stated that while the Board works on the problem, people are getting angry. She asked if it would be helpful for the Board to initiate a process with dispute settlement.

The Chairman asked that the County Manager assist him in arranging a meeting between the parties to discuss mediation of the issue.

SOLID WASTE ADVISORY

John McSween, Chairman of the Chatham County Solid Waste Advisory Committee, introduced HDR Engineering.

The Board of Commissioners was informed of the status of the Solid Waste Feasibility Study. The discussion focused on disposal options and the most socially acceptable environmentally safe and economically viable options of managing Chatham County's solid waste. The following options were discussed:

MSW Composting Facility (County controlled & All County MSW)
County Subtitle D Landfill
Regional Subtitle D Landfill (Surrounding Counties)
Regional Waste-To-Energy Facility
Materials Recovery Facility (an enhancement option)
Current Option (Out-of-County Disposal)

The Board of Commissioners was presented with a summary of the options and HDR's professional opinion in ranking of the options. The Solid Waste Advisory Committee developed a weighting factor to the Disposal Options as a tool that the Board may use in their decision making process.

Four major areas of concern, based on the County's Strategic plan, used in the weighing factor, were discussed as follows: Environmental, Social/Cultural, Land Use, and Financial.

By consensus, the Board decided not to investigate "The Waste-To-Energy" option due to both its high initial capital cost and the anticipated high cost per ton of waste disposal.

BOOKMOBILE

Linda Clarke, Library Director, explained that in fiscal year 1998, Chatham County created reserve funds for the purpose of bookmobile replacement. She stated that this process helps provide staff with safe and efficient equipment and helps to reduce maintenance costs which improves the overall performance of the library services program; that the existing bookmobile was purchased in 1986; that a new bookmobile is scheduled to be purchased this year; that sufficient funds have been budgeted for the purchase; that options were investigated and a formal bid was conducted by the County's purchasing agent on December 17, 2001; that only one bid was received so a second bid process was conducted on January 8, 2002; that the adopted budget for the current year included funds to purchase a diesel-powered bookmobile at an estimated cost of \$140,000; that this item had no net impact on the General Fund due to the availability of funding in the capital reserve from previous year contributions for this replacement item.

Commissioner Pollard moved, seconded by Chairman Phillips, to approve staff recommendation and award the purchase of a new bookmobile to Moroney Bookmobiles in the amount of \$97,680.00. The motion carried five (5) to zero (0).
