- Purpose and Agenda for today's meeting
- 2 Philip Bors called the meeting to order and thanked everyone for attending. Alfred "Buddy" Denise
- 3 was welcomed as a new member to the Committee.
- 4 2. Public Comment
- 5 No one from the general public provided comment.

Action Items

- 6 3. Approval of Minutes from June 28, 2011 Regular Meeting
- 7 Mr. Chodorow moved to approve June's meeting minutes with no changes. Mr. Denise seconded the motion. The motion to approve the minutes was approved with no dissent.
- 9 4. Election of Chair
- 10 The Committee's previous Chair, Faythe Canson Clark, resigned in compliance with the recently
- 11 enacted Chatham County Citizen Advisory Committee Policy which, among other conditions,
- prohibits membership in more than one Advisory Committee. The term of the Chair is to run until
- the end of December 2011 with re-election possible January 2012. The members of the Committee
- 14 were asked to consider volunteering to chair the committee. In the interim, Mr. Bors will continue
- 15 as Vice-Chair.
- 16 5. Pittsboro Comprehensive Transportation Plan (CTP)
- 17 The Town of Pittsboro has adopted a CTP, with discussion about obtaining additional public
- comment through a public hearing. Chatham Board of Commissioners ("BoC") will also be asked to
- adopt and endorse the CTP as the area encompassed by the CTP extends into the county's
- 20 jurisdiction. Ms. Emerson made a motion that the TAC should support the CTP and communicate its
- support to the BoC. Mr. Denise seconded the motion which passed with a vote of 4-1.

- Chatham County Comprehensive Transportation Plan (CTP), by Brendan Merithew and Scott

- 26 Mr. Merithew presented the latest schedule for milestones and ultimate adoption of the CTP:
- 27 collection and forecasting of roadway data by 11/2011; completion of the Siler City model by
- 28 2/2012; develop the draft CTP by 6/2012; local CTP adoption by municipalities, Chatham County BoC
- and RPO by 10/2012; adoption by NCDOT Board by 12/2012; final report and documentation by
- January 2013. Mr. Merithew, with assistance from Mr. Bors and Ms. Guilbeau, will draft a public
- 31 opinion survey and submit it to the Committee for its comment and to add its particular questions,
- 32 prior to submitting it to the general public, possibly by Survey Monkey, possibly soliciting the input
- of the public by utility bill insert. There was some discussion concerning the status of the Siler City
- 34 Subcommittee with Mr. Bors agreeing to discuss the matter with the Chatham County Manager.
- 35 Ms. Guilbeau will conduct the appropriate advertising for the subcommittee and Mr. Denise and
- 36 Ms. Emerson will also join the Siler City effort and report back to the Committee.
- 37 7. Update and next steps on the Chatham County Bicycle Plan
- 38 Ms. Guilbeau will send out a notice for volunteers to form a Bicycle and Pedestrian Subcommittee.
- 39 This subcommittee will be formed after Committee membership increases. Subcommittee
- 40 membership notice will go out, at least, to groups and individuals who became known to the
- Committee through the Bicycle Plan survey process earlier this year.
- 42 8. Continuation of Carpooling Discussion
- 43 Mr. Chodorow presented the latest draft flyer which describes various means for residents to
- carpool, ride-share and use mass transit within and among Chatham and neighboring counties. The
- Committee members are to review the flyer and provide any comment to Mr. Chodorow prior to the
- 46 next meeting of the Committee. Mr. Chodorow will also explore the cost to obtain a Spanish-
- 47 language translation. The revised flyer will also be sent to other groups and organizations for their
- 48 review, whereupon Mr. Bors will explore sources of funding for printing and distribution of the final
- 49 version.

- 9. Updates from Staff and/or the Executive Committee
- 51 Ms. Guilbeau presented a number of updates: (1) the 2011-12 secondary road paving schedule will
- 52 be presented at the September Committee meeting by Reuben Blakely of NCDOT; (2) there was a
- 53 TARPO meeting last week, during which the list of 'Roads For Study' was distributed. Individual
- 54 Committee members are invited to review the list and provide any comment concerning
- 55 prioritization of the projects to Ms. Guilbeau (highway projects can be prioritized by the giving of a
- 56 maximum of 100 points down to a minimum of 4 points, while bicycle projects and pedestrian
- maximum of 100 points down to a minimum of 4 points, while dicycle projects and pedestrian
- 57 projects are to be ranked by the top five, respectively); (3) Chatham Transit will consider its 5-year
- 58 plan at its next meeting. Changes to on-demand service provided by Chatham Transit throughout
- 59 the county commenced in August, including route name changes, service schedule changes and a
- fare increase.
- Mr. Bors reported that Chapel Hill Transit is seeking new members for their Advisory Board.
- 62 Mr. Bors reported that he will draft a letter to the BoC concerning the impact of the new Committee
- Policy on membership on the Committee (see item 4, above).
