#### WESTERN WAKE COUNTY WASTEWATER TREATMENT UPDATE

Tommy Esqueda, with CDM Hazen and Sawyer Environmental Engineers & Scientists, gave a status report on the Western Wake County Wastewater Treatment including completed activities, service area boundaries, wastewater flow projections, treatment facility and discharge options, and seven options selected for detailed evaluation. A copy of the project status report is attached hereto and by reference made a part hereof.

#### **FIRE INSPECTIONS DISCUSSION**

Tom Bender, Chatham County Fire Marshall, explained the specifics of the North Carolina State Building Code related to Chatham County, inspection schedules, personnel inspection and re-inspection hours. He informed the Board of the growing demands on his department and the need for an additional fire inspector. He stated that the number of inspections the department is handling continues to grow every year; that it is becoming overwhelming; that the department has taken on sixty new inspections this year; that his department is mandated by the State to conduct inspections which include businesses and schools (which are inspected twice annually); and that while his department will continue to do the best that it can without additional manpower, the level of service will likely decline. He reviewed newspaper articles relevant to fire prevention errors, litigation, wrongful death lawsuits, negligence, and other issues which could add additional responsibilities to the Fire Marshall's Office.

### **ECONOMIC DEVELOPMENT GRANT**

Staff met during the prior week with officials of the Department of Transportation (DOT) regarding the economic development grant which DOT offers; that during a previous presentation that Mr. Kindley indicated that the State had funds up to \$400,000 to help with economic development in the County; that they had some concerns with what has been outlined due to it not meeting State standards; and that staff has asked for further review from engineering.
