- 15 Mr. Gillis seconded the motion. The motion was approved with one abstention.
- 16 5. Election of Chair, Vice Chair and Secretary
- 17 The Committee's previous Chair resigned in compliance with the BoC policy which prohibits
- membership in more than one Commissioner-appointed committee. The term of the Chair is to run
- through December, 2011. Next election is scheduled for January, 2012. In his role as Vice Chair,
- 20 Mr. Bors has been serving as Interim Chair.
- 21 Mr. Bors opened the floor for nominations for the office of Chair. There being no nominations,
- 22 Mr. Bors agreed to continue to serve as Interim Chair. Mr. Bors then opened the floor for

- 23 nominations for the office of Vice Chair. There being no nominations, Mr. Bors agreed to continue
- to serve as Vice Chair. Mr. Bors then opened the floor for nominations for the office of Secretary.
- 25 There being no nominations from the floor, Mr. Bordsen volunteered to continue to serve as
  - Secretary. Mr. Denise moved to accept Mr. Bors as Vice Chair and Mr. Bordsen as Secretary; the
