The Board of Commissioners ("the Board") of the County of Chatham, North Carolina, met in the Agricultural Auditorium Building, 45 South Street, located in Pittsboro, North Carolina, at 9:00 AM on January 05, 2004.

The meeting was called to order by the Chairman at 9:00 AM.

PLEDGE OF ALLEGIANCE AND INVOCATION

Chairman Emerson invited everyone present to stand and recite the Pledge of Allegiance after which Commissioner Outz delivered the invocation.

AGENDA

The Chairman asked if there were additions, deletions, or corrections to the Agenda.

Commissioner Pollard moved, seconded by Commissioner Outz, to approve the Agenda. The motion carried five (5) to zero (0).

PUBLIC INPUT SESSION

Roland McReynolds, 1424 Bynum Ridge Road, Pittsboro, NC, commended the Planning Board and the Board of Commissioners on their diligent efforts while considering the various elements of the Compact Communities Ordinance. He expressed concern with regard to the Compact Communities Ordinance stating that he was most concerned with the "B Draft". He stated that it strikes him that after all the public process that has gone into it as antidemocratic. He asked that Draft B be removed from consideration at the afternoon work session.

Robert Eby, 1056 Fearrington Post, Pittsboro, NC, asked where Draft B came from, who authorized it, who approved it, and put it on the web site. He stated that it mysteriously appeared on December 22nd; that he thought it was a bad Christmas present for the citizens; that the Board needs to be aware of all of the safeguards that were in Draft A that were removed in Draft B; that the required placement of the wastewater treatment plant within the compact community is gone; that the definition of sprayfield locations is gone; that the required increase in size of effluent ponds gone; that the requirement for a wastewater treatment system performance bond is gone; that the requirement to use North Carolina's stormwater manual for stormwater management is gone; that the requirement that stormwater discharges be no greater after development than before is gone and replaced by "to the extent practical"; that the protection of the streams within buffers is gone; that the requirement for affordable housing inside the compact community is gone; that the requirement of Chatham County using their consultant to analyze impact statements is gone; that he feels that a developer deserves a chance to be successful as long as his opportunity does not foul the environment and is not at the expense of Chatham citizens; that appropriate regulatory features must be a part of the Compact Community Ordinance; that Draft A still has some "warts" but can serve as the basis for a fine Compact Community Ordinance; that Draft A should be sent forward to the public hearing.

Judy Hogan, PO Box 253, Moncure, NC, stated that the people of Moncure are threatened if development is not done carefully; that they are already receiving inadequate staff; that she has spoken with Animal Control who do not get to take their compensation time; that they are on duty twenty-four hours per day; that they can not handle all of the situations which arise; that she understands that the workers at the Department of Social Services have to meet in their cars due to lack of space; that the

judge came to the Board asking for a new facility; that the librarians are so stressed that their normal good nature is strained; that she knows that the Board wants to keep taxes low; that the only way to do that is to have good rules for developers; that for every dollar that resident tax-payers pay, it takes one dollar and a half in services according to a Wake County study; that the developer needs to provide services, money, schools, and library facilities so that the people do not have these types of problems; that industry helps taxes; that the pollution problem has not been solved in Moncure; that there needs to be environmental friendly industries in the County that are not polluting; that she thinks that the developer got to the staff and had Draft B put in; that the Board has to stand up to staff and developers or the citizens will be sacrificed and all credibility will be lost.

Ed King, 118 Baldwin Farm Road, Pittsboro, NC, stated that he was as surprised as many others who have been following the compact communities process from the beginning; that he feels what is happening is an erosion of respect for the LUPIC process; that LUPIC spent months working out the details of the Compact Communities Ordinance coming up with a complete, comprehensive account of what Chatham County should look like in years to come from everyone's standpoint; that they have been moderating their viewpoint and objections to the extreme developers wishes to try to build a huge development in the north; that they have come to middle ground and thought that they were going to have the process maintain itself; that it had done so until the Draft B appeared; that he feels that Draft B is one of the most undemocratic things and railroaded drafts he has ever seen; that he has no idea from whence it came, who authorized it, how it will be used, whether it will be used equally with the other one, etc. He suggested that Draft B be dropped and that the first draft be used for the basis of the work session.

Commissioner Atwater stated that it was inappropriate for anyone to make comments regarding personal attributes.
