MINUTES CHATHAM COUNTY BOARD OF COMMISSIONERS REGULAR MEETING FEBRUARY 02, 2004

The Board of Commissioners ("the Board") of the County of Chatham, North Carolina, met in the Agricultural Auditorium Building, 45 South Street, located in Pittsboro, North Carolina, at 9:00 AM on February 02, 2004.

The meeting was called to order by the Chairman at 9:02 AM.

PLEDGE OF ALLEGIANCE AND INVOCATION

Chairman Emerson invited everyone present to stand and recite the Pledge of Allegiance after which he delivered the invocation.

AGENDA

The Chairman asked if there were additions, deletions, or corrections to the Agenda.

Commissioner Pollard moved, seconded by Commissioner Morgan, to approve the Agenda. The motion carried five (5) to zero (0).

Commissioner Pollard asked if the Board should ask Representative Joe Hackney and the Governor (by letter) to again review how sales tax disbursements are distributed back to the counties.

Commissioner Atwater asked Mr. Nelson, if when he speaks to the state agencies, were they moderately, greatly, or not concerned about the CDBG project.

Mr. Nelson stated that he would need to speak with his manager who worked on the project to get an accurate answer after which he would report back to the Board.

Commissioner Morgan asked for an update on the CDBG after Mr. King comes on Thursday.

The County Manager reported on the following:

US #64 Corridor Study:

Information on the US #64/NC 49 Corridor Study is now on the website. There will be a presentation by David Wasserman at the March 15, 2004 Board of Commissioners' meeting.

Cooperative Extension Luncheon:

Representative Joe Hackney will be in attendance at the Cooperative Extension Luncheon.

COMMISSIONERS' REPORTS

Audio Concerns:

Commissioner Pollard stated that almost every time the Board meets, someone expresses concern that they cannot hear what is being said. She asked if something could be done to improve the situation. A suggestion was made to look into purchasing stands for the microphones to help alleviate the problem.

County Parking:

Commissioner Outz stated that he thought that the first row of parking spaces next to the Courthouse Annex should be designated as thirty-minute parking limit.

The County Manager stated that he would check into the enforcement process of the limited parking.

Expenditure Reducing Work Session:

Commissioner Outz stated that he would like to have a work session dedicated to reducing County expenditures.

Livestock Sewer System:

Commissioner Outz stated that he would like to check to see if there was a possibility in allowing the livestock market to hook into sewer system crossing their property.

Chairman Emerson asked if a letter could be sent asking for an exception to the policy.

Stephen Talbert, Public Works Director, stated that he thought that there was an issue with regard to Siler City about the hook-up.

Chairman Emerson stated that he would speak with the Siler City Town Manager, Joel Brower, with regard to the hook-up stating that he thought that the issue was with the state not Siler City.

The County Manager stated that there were definite boundaries within the project.

The County Attorney stated that he negotiated the easement with Mr. Horney for just compensation; and that he told him that he had looked at the property where the easement was going and was not interested in taping on to it at that location.

Mobile Home Located at Waste Management:

Commissioner Outz stated that he had received a telephone call with regard to the mobile home located at the Waste Management Center stating that they were interested in using it as a ham radio station.

The County Manager replied that there was a spare mobile home that was acquired after Hurricane Fran and that FEMA was deciding whether it belonged to them or to the County.
