# END OF CONSENT AGENDA

#### **PUBLIC INPUT SESSION**

**Reverend Terry Dorsey**, PO Box 1520, Pittsboro, NC, stated that Chatham is primarily a Christian county; that God asked Noah to fill the ark with animals; that the well-known image for the kingdom of God is the lion and the lamb; that two years of asking, writing and calling, some are now contacting him; that a "task force" consisting of neighbors and friends of the shelter director and consultants who have stated public opposition to any study has a negative effect; that other counties have feared a professional study of their shelter only to discover many hidden benefits and benefactors;

that leaders strengthen their authority when they assert it and when they honor previous decisions made by those in office; that a resolution was adopted in May 1992 which created an Animal Shelter Advisory Committee; that accountability and performance are measured in many ways but are not opinions; that the weak performance of the Chatham County Animal Control Department is reflected in their own statistics as well as in the complaints of citizens; that issues like animal abuse and neglect are serious; and that they are directly linked to violence against people and indicators of such. He asked where the Board stood on this issue.

**Dr. Kathleen Dorsey**, PO Box 1520, Pittsboro, NC, discussed animal control issues and the desire to reinstitute the Animal Shelter Advisory Committee that was originally created in May, 1992 by the Chatham County Board of Commissioners.

# **RURAL OPERATING ASSISTANCE PROGRAM**

# Public Hearing:

Public hearing to receive public comments on a the FY 2004-2005 Rural Operating Assistance Program

There was no one present who wished to make public comments.

Commissioner Morgan moved, seconded by Commissioner Pollard, to close the public hearing. The motion carried five (5) to zero (0).

**FY 2004-2005 Rural Operating Assistance Program:** Consideration of a request to approve the Rural Operating Assistance Program (ROAP) sub-allocation recommendations as made by the Chatham Transit Network Board of Directors

Commissioner Pollard asked that Chatham Transit Network make a presentation before the Board of Commissioners at a future Work Session.

Commissioner Pollard moved, seconded by Commissioner Morgan, to accept the Rural Operating Assistance Program sub-allocation recommendations as follows and approve the Certified Statement:

NCDOT/PTD has allocated \$32,890 in Rural General Public (RGP) funds to Chatham County for FY 2004-2005. RGP funds can only be allocated to the local Community Transportation System which in Chatham County is Chatham Transit Network (CTN). These funds require a local match which is provided to CTN by United Way of Chatham County.

In addition to our formula allocation, CTN is also requesting \$25,000 in Discretionary Rural General Public Funds (DRGP). These funds are used to support public transportation beyond that which can be supported with formula RGP funds. CTN uses the DRGP funds to operate the Chapel Hill route. This year NCDOT/PTD has placed a two-year limit on receiving these funds for a particular project. After the two-year period, the project must be funded either with the formula allocation or local funds. CTN in unison with other counties along the highway 64 corridor has appealed to NCDOT/PTD to bring this route into their intercity program.

Work First Transitional/Employment funds can only be allocated to the Community Transportation System (CTN) or Department of Social Services. Chatham Transit Network has always been the recipient of these funds. The total

amount allocated for Chatham County is \$5,952.

The EDTAP allocation for the County is \$48,629. The Board of Directors of Chatham Transit Network is recommending the following distribution of these funds:

The allocation to Chatham Transit Network will be used in the following manner:

#### **COMMISSIONERS' REPORTS**

### **Gasoline:**

Commissioner Outz voiced concern with regard to escalating gasoline prices. He asked that letters be sent to each department leader asking that they voluntarily reduce driving County vehicles by 5-10%. He also asked that routine tire rotation be preformed to maximize gasoline performance.

#### **Elmer Keck Road:**

Commissioner Outz stated that there were thirteen residents living on Elmer Keck Road; that they would like help in expediting the paving of their road; and asked that a letter be sent to the North Carolina Department of Transportation requesting that this road be moved up on the priority paving list.

# **County Parking:**

Commissioner Outz asked about designated parking for citizens coming to County offices to attend to business.

The County Manager stated that the signs have been ordered for the designated spaces.

#### **Annexation of Chatham County Land:**

Commissioner Outz asked that a letter be sent to Representatives Joe Hackney, Ellie Kinnaird, and Arlie Culp requesting their consideration and help in introducing a bill asking that Chatham County land cannot be annexed without approval by Chatham County.

# **Meeting with Town of Pittsboro:**

Commissioner Outz asked that a meeting with the Town of Pittsboro be held regarding water.

The County Manager was asked to contact the Pittsboro Town Manager for dates.

# **Southern Railroad Repair:**

Chairman Emerson stated that there was a portion of Southern Railroad, located in Bear Creek at Chatham Central High School, which needs repair. He asked that the County Manager contact the proper officials regarding this matter.

#### Jordan Lake Roadsides:

Paul McCoy stated that approximately two hundred twenty families gave up their homes and land for Jordan Lake to be built. He stated that he was very concerned that the North Carolina Department of Transportation, Highway Division, did not keep the bushes trimmed and the roadside mowed. He stated that this was the first impression that most people had when coming into Chatham County; that he was afraid that it would give economic development a bad name with regard to recruiting new businesses in the County; that he believed that the Board of Commissioners could make it happen by contacting Mr. Tippet with the NCDOT; that the lake is a beautiful asset; and that there needs to be a coordination of continued efforts to make the lake and surrounding roadsides once again presentable.
