## **BOARD OF COMMISSIONERS' MATTERS**

Mr. Orlan Johnson and Mr. Paul Bauer informed the Board of a problem that they are having with a large number of vicious dogs running loose in their neighborhood. They stated that it has evolved into a dispute with the dog's owner and the owner making threats against his neighbors. They asked the Board to provide resources for a solution in this matter.

The County Attorney explained that Animal Control had obtained a warrant against one of the owners; that they went to court; that he learned from the Health Department and Animal Control that the warrant did not cite the ordinance number and therefore there was no valid charge; that the judge dismissed the case; and that he had talked with Animal Control and the Health Director.

## **NON-PROFITS**

Jody Minor and Dan Stroupe reviewed the combined non-profit process between Chatham County Government and The United Way of Chatham County.

They reviewed the application format, combining County and United Way information requirements, which requires centralized application distribution. They gave a comprehensive view of program services for County residents and important eligibility requirements as follows:

- The United Way of Chatham County contributed \$9.89 to each unit of service

# DEPARTMENT OF SOCIAL SERVICES REAPPOINTMENT

Commissioner Pollard moved, seconded by Carl Outz to reappoint Albert P. McClain, 715 Hill Street, Siler City, NC, to the Chatham County Board of Social Services, term beginning July 1,2004 and ending June 30,2007. The motion carried four (4) to zero (0).

## SILK HOPE SCHOOL WATER MAIN EXTENSION

The County Manager explained that given the need for water at Silk Hope School and the timing of the Western Transmission Main Construction, the initial route of the water main could extend from the Town of Siler City's existing 12" water main located at the Wal Mart Shopping Center and extend from this main east along Highway #64 crossing the Rocky River to Silk Hope Road and then along Silk Hope Road to the school; that as the western transmission main is constructed, water service would then be supplied by the Chatham County Water System and the connection to Siler City's system would be an emergency connection for the purpose of transmitting water in either direction; that the project would involve the installation of approximately 4,200 linear feet of water main along US Highway #64 and 23,000 linear feet of water main along Silk Hope Road; that the total estimated project cost is \$822,575; and that this includes construction, contingencies and engineering design.

He further explained that "Section I – Design Services" were amended to include design, permitting, and bidding procedures for the Silk Hope School water main; that "Section II – Construction Administration Services" were amended to include Silk Hope School Water Main; and that "Section III – Payment – Task Order #2 Design of Final Plans and Specifications" were amended to include an increase of \$46,000.00 for the Silk Hope School Water Main; that "Task Order #3 – Construction Administration shall remain at the current amount of \$399,411.00; and that they anticipate that the amount specified in this section will be sufficient to provide the additional construction administration services for the Silk Hope School Water Main.

Commissioner Morgan moved, seconded by Commissioner Pollard, to approve the Design of Final Plans and Specifications, to include an increase of \$46,000 for the Silk Hope School Water Main.

The motion carried four (4) to zero (0). The Project Ordinance and a copy of the estimated project costs are attached hereto and by reference made a part hereof.

# NC DEPARTMENT OF TRANSPORTATION

Commissioner Pollard asked the County Manager to write a letter to the NC Department of Transportation regarding the correction of the water lines located under the newly constructed portion of Highway #15-501. By consensus, the Board supported this request.

## TRIANGLE J BILLING

# **Title V Senior Employment Program:**

The County Manager explained that Triangle J invoices each member county for their respective local dues and for the local aging program match; that the aging local match typically included monies for planning, the Ombudsman Program, and the Senior Employment Program; that the County paid its local dues for membership in Triangle J; that the billing for local aging match remains unpaid; that the unpaid amount from the two invoices amounts to \$34,581; that the local match is mandatory for participation in the Area Agency on Aging and the accompanying funding from the Older Americans Act Block Grant funds for Chatham which amounts to over \$380,000 this year for the County; and that included in the amount due is the 2003 billing for the Title V Senior Employment Program (\$7,326); that the Title V Program has since been discontinued; that they are suggesting that Chatham County be credited for that expense; that this action would lower the total to \$27,255; and that with Triangle J's acceptance of payment in this amount, it would become current with its accounts.

Commissioner Pollard moved to pay the past due bill in the amount of \$27,255 out of Fund Balance.

Commissioner Morgan asked for more detailed information as to the nature of the expenses.

After further discussion, Commissioner Pollard withdrew her motion.

## RADIO COMMUNICATION TOWER

The Finance Officer asked for approval of approximately \$9,000 to complete the radio installation on the UNC Tower.

Commissioner Morgan moved, seconded by Commissioner Pollard, to approve the increase in the amount of money, not to exceed \$40,000.00, to complete the radio installation on the UNC Tower. The motion carried four (4) to zero (0).

#### **BUDGET**

The Board reviewed portions of the FY 04-05 Recommended Budget.

#### **Non-Profits:**

Commissioner Pollard moved, seconded by Commissioner Morgan, to accept Management's recommendation and approve the FY05 Recommended Funding for Non-Profits, attached hereto and by reference made a part hereof. The motion carried four (4) to zero (0).

#### **Health – Animal Control:**

Commissioner Morgan moved, seconded by Commissioner Pollard, to approve the Animal Control budget as recommended by the County Manager and to authorize the money for the Animal Control External Study but that the Health Department would have to return to the Board of Commissioners for the authorization to spend it. The motion carried four (4) to zero (0).

The first round of budget review was completed, and the Board will reconvene on Tuesday, June 1, 2004, 1:00 PM for continued discussion of the budget.

# Joint Meeting with Board of Education:

The Board will hold a joint meeting with the Chatham County Board of Education on Wednesday, May 19, 2004 at 1:00 PM at the School Administrative Offices.

## **Public Hearing on Water Districts:**

A public hearing will be held on Thursday, May 27, 2004 at 6:00 PM in the District Courtroom to receive public comments on the Northwest, Southwest, and Southeast Water Districts.

## **Joint Meeting with Town of Pittsboro:**

By consensus, the Board agreed to hold a joint meeting with the Pittsboro Town Board on Thursday, June 10, 2004 at 7:00 PM, location to be determined.

## **RECESS**

Commissioner Morgan moved, seconded by Commissioner Outz, that the meeting be recessed to the regularly scheduled Board of Commissioners' meeting in the District Courtroom. The motion carried four (4) to zero (0), and the meeting was recessed at 5:16 PM.
