The County Manager reviewed the Work Session Agenda.

HONEYWELL INTERNATIONAL, INC. APPEAL

Kim Horton, Chatham County Tax Administrator, reviewed the phases involved in the proposal from Tom Tinker with regard to an appraisal for the Honeywell International, Inc. appeal.

Commissioner Morgan moved, seconded by Commissioner Pollard, to approve the estimate of both phases up to \$60,000.00 for Phase I and Phase II plus out-of-pocket expenses. The motion carried five (5) to zero (0). Other expenses will be reviewed at a later date.

HEALTH DEPARTMENT ACCREDITATION

Dorothy Cilenti, Chatham County Health Director, explained the reasons for the requested support for accreditation of the Chatham County Health Department. She stated that accreditation of local public health agencies assures that local health departments have the capacity to provide essential public health services and that accreditation is essential to raise the effectiveness of the public health system in the state. She showed a video of the six North Carolina counties that had been selected for the accreditation pilot program.

After considerable discussion and by consensus, the Board decided to place the resolution on the Agenda for consideration at the September 20, 2004 Board of Commissioners' meeting.

INCREASE OUT-OF-STATE PAPER FEES
