# MINUTES CHATHAM COUNTY BOARD OF COMMISSIONERS REGULAR MEETING DECEMBER 06, 2004

The Board of Commissioners ("the Board") of the County of Chatham, North Carolina, met in the District Courtroom, located in Pittsboro, North Carolina, at 6:00 PM on December 06, 2004.

The meeting was called to order by Commissioner Emerson at 6:00 PM.

## PLEDGE OF ALLEGIANCE AND INVOCATION

Commissioner Emerson welcomed everyone in attendance and invited those present to stand and recite the Pledge of Allegiance after which he delivered the invocation.

# **ATWATER COMMENTS**

## **Salaries:**

Commissioner Atwater stated that owing to the late hour of adjournment at the last Board of Commissioners' meeting, he had asked for the opportunity to postpone a few items of business until the December 6, 2004 Board of Commissioners' meeting.

Commissioner and NC Senator-elect Atwater moved to increase Board member salaries and travel as follows from the floor:

He urged the Board to fill the position for Sedimentation and Erosion Control that was approved in last year's budget and to make certain that the funding is in place for the upcoming year stating that with the amount of growth occurring in Chatham County, that it is essential that a person is put in place and get the program up and running before ground is cleared in the critical areas.

# **Planning Issues:**

Keith Megginson, Chatham County Planning Director, asked that the Board consider holding an additional December meeting to consider planning issues prior to year's end.

Commissioner Emerson moved, seconded by Commissioner Cross, to set December 13, 2004, 9:00 AM, as the date on which to hold an additional Board of Commissioners' meeting to consider planning issues. The location is to be announced.

## **COMMISSIONERS' REPORTS**

#### **Consent Agenda Rules:**

Commissioner Morgan moved, seconded by Commissioner Outz, to change the rules for the Consent Agenda.

After considerable discussion, Commissioner Outz withdrew his second to the motion.

Chairman Emerson moved to table the motion. Commissioner Barnes seconded the motion. The motion carried five (5) to zero (0).

#### **Hunting Permit:**

Commissioner Outz asked if a person had to have a written permit to hunt and/or ride four-wheelers on another person's land.

The County Attorney explained that one would have to have a permit while carrying a firearm and they might be trespassing if they were riding without permission.

## **Sports Arena:**

Commissioner Outz stated that he was still receiving calls with regard to noise at the sports arena and that the ordinance needs to be revised. He asked what they could do to correct the situation.

The Sheriff stated that they were taking readings every thirty minutes and that if they received calls in between those times, they would take another reading.

## **Keiser Roth Building:**

Commissioner Outz asked about the Keiser Roth Building.

Commissioner Morgan stated that they were trying to take care of the sewage issue and the matter is still being pursued.

#### **Graves:**

Commissioner Outz asked about removal of the old graves.

Chairman Morgan stated that there was no action taken at the last meeting; that there are approximately 260 known graves located there; that the statute reads that the graves can not be relocated without Commissioner approval.

### **School Bonds:**

Commissioner Outz asked how much is owed on school bonds. A discussion ensued on the bond issue and the May municipal election.

## **Home and Community Block Grant Committee:**

Commissioner Emerson moved to reappoint Ed Spence, 68 Pinewood Drive, Siler City, NC, to the Home and Community Block Grant Committee. Commissioner Outz seconded the motion. The motion carried five (5) to zero (0).

## **Mid-Carolina Workforce Development Board:**

Commissioner Emerson moved to appoint Morton Dark, 10318 US Highway #64, Siler City, NC, to the Mid Carolina Workforce Development Board. Commissioner Outz seconded the motion. The motion carried five (5) to zero (0).

#### **Chatham County Water Advisory Board:**

Commissioner Emerson moved, to appoint Charles Eliason, 117 North Chatham Avenue, Siler City, NC, to the Chatham County Water Advisory Board. Commissioner Outz seconded the motion. The motion carried five (5) to zero (0).

Commissioner Emerson moved, seconded by Commissioner Cross, that there being no further business to come before the Board, the meeting be adjourned. The motion carried five (5) to zero, and the meeting was adjourned at 7:36 PM.
