- 16 year 2040 and explained that NCDOT plans for a level-of-service (LOS) "D" in the CTP. He then
- 17 engaged the group in a discussion of the anticipated future highway capacity deficiencies.
- 18 Mr. Bors asked when the group would begin discussing the bicycle and pedestrian elements of the
- 19 CTP. Mr. Walston stated that it would be sometime in the next few months. The group then
- 20 discussed how the Pittsboro Pedestrian Plan will be integrated into the CTP and how to proceed
- 21 with pedestrian planning in Siler City and transit planning throughout the county.
