Resolution of the Chatham County Board of Commissioners

FOR THE ADDITION OF STREETS OR ROADS TO THE NORTH CAROLINA SYSTEM OF SECONDARY ROADS

LEGEND OAKS SUBDIVISION
PHASE 1 & 2 SUBDIVISION

WHEREAS, Chatham County wishes to cooperate in any way possible with the North Carolina Department of Transportation, Division of Highways, to place streets and roads within the County on the North Carolina System of Secondary Roads, operated and maintained by the North Carolina Department of Transportation; and

WHEREAS, from the centerline intersection of US 15-501 to the centerline of Legend Oaks Drive with Legend Oaks Drive, 0.863 miles (50 FT ROW).

WHEREAS, from the centerline intersection of Legend Oaks Drive to the center of cul-de-sac (Grassy Creek Way), 0.099 miles (45 FT ROW).

WHEREAS, from the centerline intersection of Legend Oaks Drive to the center of cul-de-sac (Peak View Place), 0.21 miles (50 FT ROW).

WHEREAS, from the centerline intersection of Legend Oaks Drive to the center of cul-de-sac (North Dueling Oaks Drive), 0.147 miles (45 FT ROW).

WHEREAS, from the centerline intersection of North Dueling Oaks Drive to the center of cul-de-sac (Little Bend Court), 0.09 miles (45 FT ROW).

WHEREAS, from the centerline intersection of Legend Oaks Drive to the center of cul-de-sac (South Dueling Oaks Drive), 0.106 miles (45 FT ROW).

NOW, THEREFORE, BE IT RESOLVED, that the Chatham County Board of Commissioners requests that subject streets, Legend Oaks Drive, Grassy Creek Way, Peak View Place, North Dueling Oaks Drive, Little Bend Court, and South Dueling Oaks Drive be added to the North Carolina System of Secondary Roads upon meeting all criteria as established by the Department of Transportation.
