## **PUBLIC INPUT SESSION**

Bob Knight asked to discuss the new Bojangles and Waffle House being built in Pittsboro and the fact they are not handicap accessible in his opinion. He stated the doors are not automatic and do not have push buttoms. At the Bojangles, from the outside one cannot be seen from the cash registers. Handicapped individuals want to be able to be let in. He stated all doors open to the outside and not to the inside. He asked for the staff or county attorney to check to see if it is handicap accessible and if not encourage them to have the push buttons or automatic doors. He would like all businesses in Chatham County to take that extra step and install push buttons and be handicap accessible. He suggested meeting with the Town of Pittsboro because the businesses are in city limits. He would like a county ordinance passed that all new businesses be equipped with push buttons. He believes the County should send a paper to each town to also take that extra step to put push buttons.

## **PUBLIC HEARINGS**

Angela Birchett, land use administrator, reviewed the specifics of the request.

The Chairman opened the public hearing for comments.

Nick Robinson, attorney with Bradshaw and Robinson in Pittsboro, spoke on behalf of the applicant, NNP-Briar Chapel, LLC who wished to make amendments to the Compact Communities Ordinance. Mr. Robinson stated there was a give and take with the Planning Staff but with the completion of the meeting the staff was comfortable with what the applicant was proposing.

Mr. Robinson stated there were three minor amendments being proposed and they were fairly straight forward. One amendment is simplifying and clarifying two of the wastewater provisions. A second amendment is creating an opportunity for adjoining landowners to agree to seek a waiver for a reduction of certain perimeter buffers. The third amendment is clarifying language in regards to a practical reality relating to viewshed buffers along the commercial areas.

Mr. Robinson turned the floor over to Mark Ashness, engineer, to review the wastewater changes being requested.

- Mr. Ashness reviewed the wastewater specifics of the request.
- Mr. Robinson reviewed the perimeter and viewshed buffer specifics of the request.
- Mr. Robinson asked the Board if they had any questions.

Commissioner Elza asked if Briar Chapel had a Home Owners Association. Mr. Robinson stated they did.

Commissioner Elza asked if they would be selling wastewater to the new site. Mr. Robinson said they would not be selling it.

Mr. Ashness stated Briar Chapel Utilities would probably be sold to another utility and the customers of the US Steele tract would be customers of that Utility.

Commissioner Elza asked if there would be some kind of agreement. Mr. Ashness

stated there would be an agreement. The Utilities Commission requires the Utility to provide a service area and the Commission approves that service area.

The Chairman closed the public hearing.

Hillary Pace, planner, reviewed the specifics of the request. She stated staff is requesting discussion and input.

Vice Chairman Bock stated it sounded like statff is simply aligning the ordinance with what the state is saying the County has to do.

Ms. Pace stated that was correct. Vice Chairman Bock stated there probably

is not a lot of guidance the Board can give.

Ms. Pace

stated there is an opportunity for the Board to separate the Board of Adjustment from the Board of Commissioners.

Vice Chairman Bock stated he would support that.

Commissioner Elza stated separating the Boards would be a good idea, however, the Board of Commissioners should not give up some of the special permits. He stated for the BofAdj to hear variances and to hear appeals of the position of the zoning administrator would be a good idea.

Commissioner Elza asked why the 1000 sq ft heated part of the ordinance was not a percentage of the dwelling.

Jason Sullivan, planning director, stated the county used to have a conflict in the ordinance. One provision that said you could have a percentage of the principal dwelling up to 1000 square feet and another provision that said up to 800 square feet. A few years later the County changed the ordinance to say 1000 square feet.

Commissioner Elza stated there are some large houses in this community. One may be 4,000 square feet and they may want a guest house of 2,000 square feet. The County would not permit that. Mr. Sullivan stated that was correct.

He said the primary reason staff was bringing this to the Board is because in the unzoned parts of the County where there is no square footage limit for guidance.

Commissioner Elza stated you could end up with an accessory dwelling bigger than the principal dwelling

Mr. Sulllivan stated staff looks at heated square footage and discount the garage portion. It is not considered part of the heated square footage.

Commissioner Elza asked if the County allows accessory dwelling in garages. Mr. Sullivan stated the County does allow that.

The Board asked the planning staff to bring back with alternatives for accessory dwelling unit size and also look into other jurisdictions' methods
