## <u>15-1417</u> Presentation on Affordable Housing by the Chatham County Housing Authority

Ms. Davis stated it is hard for the Housing Authority to stay 100% leased because people can't come up with the deposits. The Housing Authority has to have 100% of their vouchers leased to get 73% administrative federal dollars.

Ms. Davis stated they are here today to ask the Commissioners to fund a Security Deposit Revolving Loan Assistance Pilot Program with \$13,000 to help with the deposits needed.

Commissioner Petty asked if they still get a percentage of the 73% funding if they don't get 100% of the leases. Ms. Davis stated they do get a percentage. He asked how they meet the shortfall. Ms. Davis stated they have no way to meet the shortfall at this time.

Commissioner Petty stated the Chatham Housing Initiative sounds like it is addressing the need to funnel people into one organization to help them with all of their housing needs.

Ms. Barrett continued the presentation by explaining how the Pilot Program will work.

Commissioner Howard clarified they would start out with the \$13,000 and someone would use the funds and then start paying the funds back to the account with the \$13,000. Ms. Barrett stated she was correct. She asked if this is a one-time request. Ms. Barrett stated they believe it can be if people pay the money back and if it is an interest account.

Commissioner Petty asked if the 220 active landlords were only apartments. Ms. Davis stated it was homes and apartments. He asked if there were enough properties for the vouchers. Ms. Davis stated there were.

Commissioner Hales asked what deposits this program would cover. Ms. Davis stated it would be the rental deposits or security deposits.

Dennis Vitolo, a landlord working with the Housing Authority, stated the security deposits have been a problem. The tenants he has had through the Housing Authority have been his best tenants. He believes the pilot program is a wonderful program.

Ted Edwards, a landlord working with the Housing Authority stated he has also had good success with the program. He too has had some of his best tenants through the Housing Authority. He also believes the pilot program is a good program.

Vice Chair Cross asked if the money would cover water and electric deposits. Ms. Davis stated no. Part of their requirements is that the applicant must have their water and electric turned on in order to move in.

Commissioner Petty asked if the landlord gets the security deposit. Ms. Davis stated the landlord doesn't get the security deposit. The Housing Authority is guaranteeing it. The landlord only gets it if there is damage.

Eugene Davis, a member of the CHI Board, stated it is a revolving guaranteed account. There will be a comprehensive inspection program and they do not anticipate there will be damages.

Commissioner Howard stated her previous statement was incorrect. The money will be paid as part of their rent to their landlord. Ms. Davis stated that is correct. Commissioner Howard stated if the tenant has no damages they will get their money back. Ms. Davis stated that is correct. Commissioner Howard clarified that the only way the fund grows is through interest. Ms. Davis stated that is correct.

County Manager Renee Paschal stated the County would need a contract if the Board approves the funding.

Commissioner Petty asked who reviews the applications to determines who qualifies for the vouchers. Ms. Davis stated staff reviews the applications. The staff is certified by the Department of Housing and Urban Development (HUD).

Vice Chair Cross asked if the people on the waiting list are qualified before they go on the waiting list. Ms. Davis stated they fill out a pre-application that determines that they go on the waiting list. When they get to the top of the waiting list they do income verification, criminal background checks, check sex offender status, verify if they are homeless, check disability status, evidence of six months of work if they are employed, and finally they look at their assets with the bank. HUD also cross references so the information can be shared between local housing authorities.

A motion was made by Commissioner Howard, seconded by Vice Chair Cross, to come to an agreement with the Chatham Housing Initiative to create a fund of \$13,000 to meet the need of security deposits with their customers and ask staff to draw up a contract and come back to the Board with how it impacts the budget. #### 15-1441 Discuss Chatham Arts using space in the Performance Building.

County Manager Renee Paschal stated the new employee for the Agriculture Center is not using the space so it is available.

Vice Chair Cross asked if there would be a contract.

The County Manager stated there would need to be a lease.

Vice Chair Cross asked if they would be limited to use of the building during normal County business hours.

The County Manager stated that could be a condition of the lease.

Chairman Crawford stated other tenants probably have weekend access.

Commissioner Petty stated he doesn't think they should be there outside of business hours.

Chairman Crawford stated he believes they should operate under the rules of the Economic Development Corporation.

Commissioner Petty and Vice Chair Cross expressed concerns about the security of the building and giving people access outside of business hours.

The County Manager stated she hears one concern being restricting use of the office space from Monday through Friday from 8:00 AM to 5:00 PM. Another concern she hears is access to meeting rooms and there are a couple of meetings spaces that she believes would be available to the Arts Council just as they would be to any other group.

Commissioner Hales stated standard business hours should be part of the lease agreement.

Commissioner Howard stated the Arts Council is currently paying \$480/mo. The Executive Director works two days a week for six hours a day.

Commissioner Petty stated the space in the arts building in Siler City may be a possible option for the organization.

Commissioner Hales stated money would be an issue at that location and the goal is to help the Arts Council have an office space that they don't need five days a week and do not have to pay close to \$6,000 a year in rent.

Commissioner Howard stated the proximity to the EDC and the Convention and Visitors Bureau are important and the majority of the Board for the Arts Council is from the Eastern part of the County.

Commissioner Hales stated she believes \$75 a month a reasonable rent to be considered.

Commissioner Petty is worried what kind of precedent it will set if the Board starts subsidizing rent for nonprofits.

Vice Chair Cross suggested staff look at the square footage office rental rate in Pittsboro to come up with a rental rate.

A motion was made by Commissioner Hales, seconded by Commissioner Howard, that staff put together a lease with the Chatham Arts Council for a space in the Performance Building with staff looking at appropriate rent costs.. The motion carried by the following vote:

The County Manager stated The Council on Aging will be holding Candlelight Reflections event on Thursday, November 4, 2015 at 7:00 PM at CCCC to honor family caregivers. They would like one of the commissioners to present the resolution the Board approved this evening. Chairman Crawford agreed to attend the event and present the resolution.

The County Manager stated the Marines Toys for Tots will be using the old EDC office at 118 West Street in Pittsboro for about one month to collect and distribute the toys. Staff has drawn up a lease agreement.
