- 1 1. Purpose and Agenda for today's meeting
- 2 Meeting was called to order by Scott Evenson; a quorum was reached.
- 3 2. Public Comment
- 4 No one from the general public provided comment.

5 Action Items

- 6 3. Approval of Minutes from the March 26th, 2013 Regular Meeting
- 7 Minutes were approved unanimously with no changes.

8 Information & Discussion

9 4. Chatham's Comprehensive Transportation Plan (CTP), by Brendan Merithew, NCDOT

10 Mr. Merithew has posted maps and heard no comment from us. DOT will next present to town and

county boards. Any changes recommended during those presentations will be incorporated, and
 then the plan will be presented for public input, after which it will go back to the boards for hopeful
 adoption. Mr. Merithew has meetings scheduled with each municipality and county board, on June

- 14 3^{rd} , June 17th, and June 24th.
- Matt Alexander asked whether or how newly announced DOT funding will impact Chatham Co.; no
 definitive answer on this topic at this time.
- 17 TAC needs to decide how many public meetings we should hold and when and how to hold them.
- 18 Discussion of possible public input dates revealed the last two weeks of July as good options, on
- days between Monday and Thursday of each week. Mr. Bors suggested having a Spanish translator
- 20 on hand during input meetings, possibly leveraging the Chatham Co. Hispanic Liaison. TAC agreed to
- 21 tentatively plan to hold three meetings, one in Pittsboro, one in Siler City, and one in Moncure. Mr.
- 22 Gerarden suggested meeting times spanning daytime and evening as well as using a URL shortener

- like "Tiny URL" to provide an easy link to CTP maps on the Chatham Chatlist or other placesmeetings will be listed.
- 25 Discussion of meeting format ensued. Mr. Merithew suggested an open house, perhaps with a short 26 presentation to be repeated periodically. TAC members will consider dates and choose a couple of 27 days to go with, tentatively planning to hold meetings from 4-7 PM on the chosen days. Each 28 meeting will have the same content, so people can attend whichever is most convenient for them. 29 Discussion of where to advertise meetings resulted in: DOT website, Chatham Chatlist, and possibly 30 the Chatham Co website and Pittsboro website. Additional suggestion was made that we write an 31 article ourselves for submission to Chatham Co. News and Record the week before the meeting- this 32 is a good way to get info out there for free rather than paying for advertising space.
- 5. 2012-2013 Secondary Road Improvement Program, NCDOT (presented by Hillary Pace)
- The proposed resolution will be presented to the county commissioners for approval in May. Money
 is being spent on projects at North Chatham Elementary, with the remainder held back for other
 items; see details in program report distributed by Ms. Pace at the meeting.
- 37 6. Update from Bike/Ped Subcommittee
- Bike/Ped subcommittee did not meet the week prior to the regular TAC meeting, so no updateavailable.
- 40 7. Updates from Staff and/or the Executive Committee
- Matt Day updated us on the Locally Coordinated Human Transportation Plan, which is being
 updated in the near future. There will be a workshop on Fri. 4/26 in Chapel Hill, open to the public
 though primarily geared toward transit planners for the purpose of going through transit needs to
 determine how to plan for improvements. Groups involved include Chatham Transit Network and
 Orange Public Transportation. There is a survey available at tarpo.org, click on the LCP link to view.
- Ms. Pace updated us on plug-in vehicle readiness plan, the NC PEV Readiness Plan hosted at
 advancedenergy.org. Discussion ensued, outcome of which is that the TAC would like to consider
 adding a note to the CTP suggesting that the PEV plan be considered in project planning going
- 49 forward.
- 50 Mr. Alexander asked whether the CTP information should be shared with the Chatham Co. Economic 51 Development Corp. so they can see what is planned from our end that could affect their plans.
- 52 8. TAC Committee Size Discussion
- 53 Question arose due to multiple vacant seats on TAC; would we like to reduce the committee size 54 from 11 to 8, cutting the current vacant seats that we've had trouble filling? Mr. Bors suggested we 55 stay at 11 and try to fill remaining seats with a focus on diversifying the committee. The majority of 56 the TAC members are in agreement to stay at 11. Mr. Bors suggested adding that focus as an agenda 57 item for the next regular meeting; Ms. Pace will check on the procedure for doing so.
- 58 9. Annual Report Discussion
- 59 Mr. Bors informed us that the TAC has presented to the commissioners twice in the past. It's a
- 60 straightforward process: fill out the annual report document, circulate it among the TAC
- 61 membership, and the current chair attends the commissioners' meeting to present to them. It's
- 62 possible we could have this completed for presentation at the June 17th meeting along with Mr.

- 63 Merithew's CTP presentation. In order to make that deadline, annual report document needs to be 64 submitted to Ms. Pace by June 3rd.
- 65 10. Announcements and New Business
- 66 A number of TAC members will not be available for regularly scheduled May meeting, so motion was
- 67 proposed by Mr. Bors, seconded by Mr. Alexander, and the group voted in favor of canceling that 68 meeting. Next regular meeting will be held on June 25th.
- 69 Mr. Geiser mentioned the Raleigh Ironman race at Jordan Lake on June 1st as an informational note; 70 be aware of a large contingent of racers on the roads that day.
- 71 Mr. Bors brought up Safe Routes to School. There is still money available to improve biking and
- 72 walking to school in Pittsboro and Siler City. Mr. Bors has asked Darius Sturdivant to check to find
- out the process for applying for this funding. Mr. Sturdivant plans to meet with the appropriate
- 74 people to find out how to move forward with this and how much money is available.
- 75 11. Adjourn
