#### WATER SYSTEM UPDATE

Fred Hobbs, with Hobbs, Upchurch & Associates, updated the Board of Commissioners on the Chatham County Water System Projects. His presentation, in its entirety, is as follows:

# **Water System Growth – Past Six Years:**

- Average Customer Growth from FY 00-01 through FY 04-05: 270 Customers
- In FY 05-06 Chatham County relinquished approximately 200 customers to Siler City. These customers were located on the periphery of the Siler City Water System and had become burdensome for the County to service. As part of this transfer of customers, Siler City also agreed to assume the ownership and operation of the Stockyard Road Sewer System. Therefore the FY 05-06 customer growth was not included in the calculation of customer growth rates for the Chatham County Water System. However thus far in FY 05-06 the North Chatham and Southeast Chatham Water Systems have an additional 185 customers from the previous year.

#### Key Points with Option #2

- As shown in the 10 year projections shown for production this option will carry the County well past the 10 year projection of 5.1 MGD.
- Utilizing Option #2 will commit a capacity of 6.0 MGD in the Harnett County Water System.
- With Option #2 the resultant production capacity will far exceed the 10 year projections, based on the requests for water from the Harnett County Water System it is important to secure the allocation of capacity in Harnett County. However, it is not necessary to expand the Jordan Lake WTP at this time to satisfy the 10 year demand projections.
- Allows the County to maintain the utilization of the Jordan Lake Allocation (6.0 MGD).
- Provides a potential of 12.0 MGD
- Provides available water capacity for Chatham County for the 20 year water use!
- Will cause operational problems in the short-term due to lack of water demand.
- Option #3 Expand the Jordan Lake WTP Plant Expansion to 6.0 MGD with NO Participation in Harnett County

#### Key Points with Option #3

- As shown in the 10 year projections for water production this option will carry the County past the 10 year projection of 5.1 MGD.
- Utilizing Option #3 there will be no guaranteed capacity in the Harnett County Water System.
- Selection of Option #3 would assume the following:
  - The planning period for long term water supply is approximately 10 years!
  - Confidence that the County can obtain additional allocation from Jordan Lake!
- Allows the County to maintain the utilization of the Jordan Lake Allocation (6.0 MGD).
- Does NOT provide available water capacity for Chatham County to the 20 year

    - Begin the Environmental Assessment and Design of the Connection to Harnett County.
    - Execute Water Purchase / Facilities Contract with Harnett County.

- Jordan Lake WTP Design and Environmental is in progress, permit the project and complete the Environmental Assessment and proceed with construction.

A question and answer period ensued.

After considerable discussion, Commissioner Lucier moved, seconded by Commissioner Vanderbeck, to hold a public informational session to receive input and exchange information on Chatham County's long-range water issues on January 29, 2007, 6:00 PM, to be held in the Superior Courtroom. #### **Lighting Ordinance:**

Keith Megginson, Planning Director, stated that Bob Henderson was willing to make a presentation to the Board regarding the different types of lighting fixtures and that the Board needs to set a date when they would like to hear it.

By consensus, the Board set February 05, 2007 as the date on which to hear the presentation if Mr. Henderson is available.

#### **MAJOR CORRIDOR ORDINANCE**

Larry Hicks, Major Corridor Ordinance Ad Hoc Committee Chair, stated that with the widening of Highway #15-501, there has been unchecked commercial development along the corridor, threatening to create a "strip mall" corridor between the Chatham County line and Pittsboro's ETJ; that this is contrary to both the adopted Strategic Plan and the adopted Land Conservation and Development Plan; that the latter specifically calls for the preservation of rural character through, among other things, the development of economic centers in key areas and to discourage commercial and industrial development in other settings, especially as strip commercial development and in sensitive resource area; that traffic congestion and impact on the environment are other considerations; and that similar growth challenges will exist along Highways #64 and #421, and US Highway #1.

Mr. Hicks stated that the Land Conservation and Development Plan identified economic centers, but that these have not been specifically mapped; that this has led to further degradation of the corridor along Highway #15-501; and that with the influx of development, the past Board of Commissioners noted that they had little control due to the lack of a major corridor ordinance.

He stated that they did not delve into industrial development issues in that their focus was corridor and commercial; however, to the extent that industrial development may impact this endeavor, it should be considered; that other issues include lighting, sign ordinance, buffer zones, and low impact development; that the final document will need to be tied to existing ordinances on these issues and must maintain the intent and integrity of the adopted Strategic and Land Conservation and Development Plans; that many of the items within the draft were culled from other jurisdictional ordinances; that the ideals of the proposal were carved directly from the adopted Strategic Plan and adopted Land Conservation and Development Plan; that the Ad Hoc Committee officially sunsets with the official creation of the Major Corridor Ordinance Committee; that he is present to hand-off the information from the Ad Hoc Committee to the newly formed Major Corridor Ordinance Committee and answer questions from the Board of Commissioners.

Mr. Hicks further stated that there is a draft ordinance that is being offered; that it is meant to continue discussions; that their basic intent was to talk about what was impacted by this particular ordinance; that it was not all inclusive; that it defines where four-lane highways overlap, desired places for commercial growth, and then how the overlay works in that regard. He reviewed the steps involved in drafting reviewing, getting citizen and stakeholder input, holding public hearings, approving the ordinance or ordinance revisions, and time frames as follows:

- 1. Create a small working group to research existing ordinances and provide initial recommendations for an ordinance. Consideration of existing County ordinances, i.e. the Lighting and Sign Ordinances will be provided. (Four months)
- 2. Expand the working group to include municipalities and additional stakeholders. Review and update the proposal as needed. (Four months)

- 3. Submit to public hearing. (One month)
- 4. Submit to the Planning Board for review, deliberation, and further update as needed. (Two months)
- 5. Submit to the Board of Commissioners' for review and approval. (One month)

Mr. Hicks suggested that the Board take a look at what they have offered forward to see if it is fitting in line with their expectations are for the directions of the committee and based on that, meet with the constituted Major Corridor Ordinance Committee and suggest the focus and the things that they can steer away from. He urged the Major Corridor Ordinance Committee to bring forth to the Board of Commissioners' a recommendation of the locations of the economic development centers. He further stated that it would be good to have continuity between the Town of Pittsboro (ETJ) and the County's ordinances so that the goals and guidelines can be established for the ordinance itself.

The Board asked the Clerk to provide hard copies of Mr. Hicks' information to each Board member.

Mr. Hicks thanked the Ad Hoc Committee for their many hours of hard work. The Chairman thanked Mr. Hicks for his and the group's hard work efforts.

#### **CLOSED SESSION**

Commissioner Lucier moved, seconded by Commissioner Cross, to go out of Regular Session and convene in Closed Session for the purpose of discussing the Murdock litigation. The motion carried five (5) to zero (0).

#### **REGULAR SESSION**

Commissioner Lucier moved, seconded by Commissioner Vanderbeck, to adjourn the Closed Session and reconvene in Regular Session. The motion carried five (5) to zero (0).

Commissioner Lucier moved, seconded by Commissioner Vanderbeck, to reset the meeting scheduled for January 29, 2007 from 6:00 PM for 5:00 PM in order to hold a Closed Session meeting to discuss litigation. The motion carried five (5) to zero (0).

#### **BOARD OF COMMISSIONERS' MATTERS**

#### **Board of Education Meeting:**

The County Manager stated that he had not received a confirmation of the time that the Board of Commissioners will meet with the Board of Education on February 12, 2007. He stated that it will likely be 6:00 PM or 6:30 PM.

The County Manager stated that a meeting to host a "Citizens in Government" segment will be scheduled at the next Board of Commissioners' work session.
