Enclosed please find our final plat submittal for Phase 15 South Section 1 at Briar Chapel. The approved public street names included in this phase are Chapel Lawn Avenue, Bluffwood Avenue, Logbridge Road, and Pinewood Street along with portions of Crowfoot Court and Birch Hollow Road. Approved private street names Trappers Run, Trelauny Drive, Tottenham Street, Grouse Trail, and Star Grass Trail are also included in this section. Two additional lots have been added (previously open space) within this section since the preliminary plat submission. These additional lots are located at the corner of the intersection of Logbridge Road and Bluffwood Avenue.
