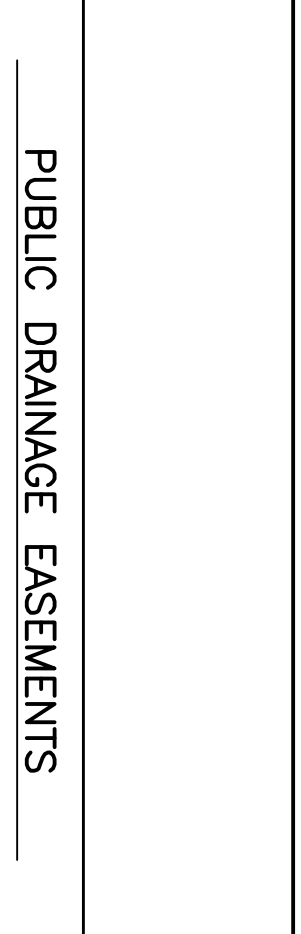
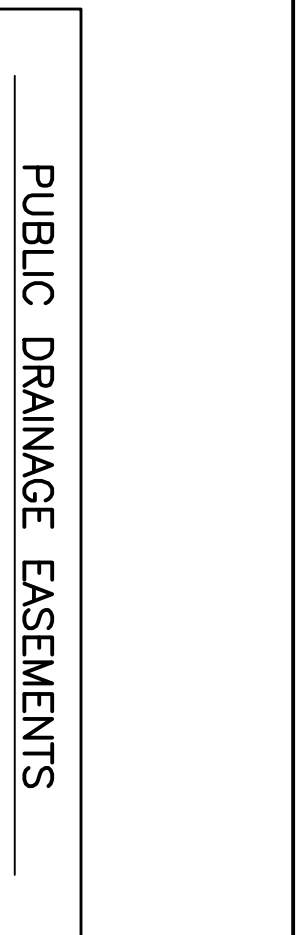
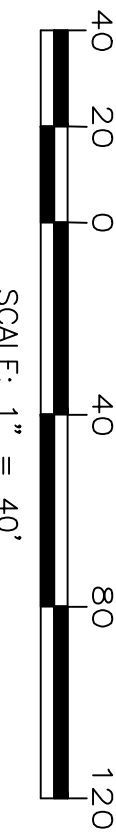


OPEN SPACE AND PUBLIC DRAINAGE EASEMENTS
