Ordinance of the Chatham County Board of Commissioners

AN ORDINANCE AMENDING THE ZONING ORDINANCE OF CHATHAM COUNTY

For Multiple General Use Rezonings

WHEREAS, the Chatham County Board of Commissioners has considered a request by the Chatham County Board of Commissioners to rezone parcels as described in Attachments "A" and "B", and finds that the amendment is consistent with the comprehensive plan of Chatham County, Plan Chatham, as described in the Consistency Statement Resolution; and

WHEREAS, the Board finds the four (4) standards, as described below, from the Zoning Ordinance have been met as Stated:

- No. 1: The alleged error in this Ordinance, if any, which would be remedied by the proposed amendment with a detailed explanation of such error in the Ordinance and detailed reasons how the proposed amendment will correct the same. No such error is alleged in this application; and
- No. 2: The changed or changing conditions, if any, of the area or in the County generally, which make the proposed amendment reasonably necessary to the promotion of the public health, safety and general welfare. The proposed amendment supports the diversification of the tax base and generation of more high-quality, in-county jobs to reduce dependence on residential property taxes, create economic opportunity and reduce out-commuting; and
- No. 3: The manner in which the proposed amendment will carry out the intent and purpose of any adopted plans or part thereof. This request supports Land Use Policy #7, Strategy 7.2 which encourages support for "rezonings for businesses uses or properties made non-conforming by the extension of zoning in 2016"; and
- No. 4: All other circumstances, factors and reasons which the applicant offers in support of the proposed amendment. None are offered by the applicant; and

BE IT ORDAINED, by the Board of Commissioners of Chatham County as follows:

- 1. The Application by the Chatham County Board of Commissioners to rezone parcels as described in Attachments "A" and "B" is approved and the zoning map is amended accordingly.
- 2. This ordinance shall become effective upon its adoption.
