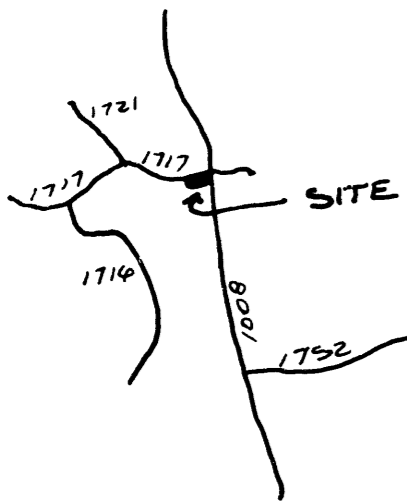


VICINITY MAP

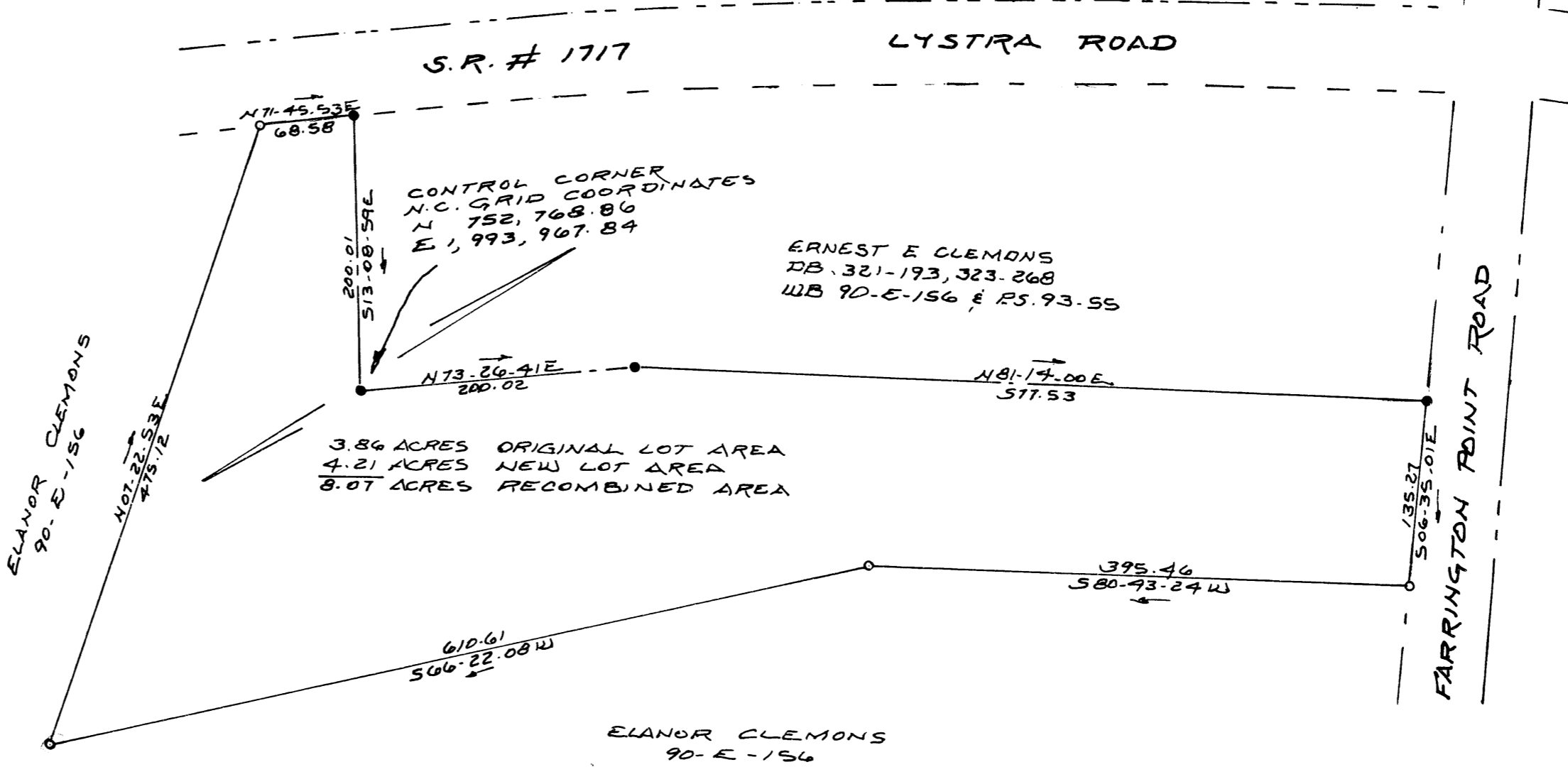
