STAFF UPDATE FOR ERAC - 8/9/18

- 1) EQ Department has been split up, each division is now a separate department
 - a. Solid Waste and Recycling division will retain EQ Department name and will incorporate new Sustainability focus and hire new Director. Coal Ash information will remain on the EQ webpage.
 - **b.** Watershed Division is now Department, all four regulations remain. Rachael Thorn is now Director and will remain staff liaison to ERAC.
- 2) The prospective Minor Variance has been resolved by staff. Confirmed with Karen Higgins, the 401 and Buffer Permitting Branch Supervisor at NC DWR Our attorney felt comfortable with her determination. The original call remains, no variance needed.
- 3) Oil and Gas Commission met on 8/7/18 main items were discussion of the draft of the Rules of Procedure for the new group, a Spring field trip to PA to tour existing fracking facilities and speak with residents, and unfinished business of previous MEC, which includes important items such as EMS resources and training for local governments affected.
- 4) Duke Energy Cape Fear Plant submitted an application Zoning Consistency Determination for Air Quality Permitting of Ash Benefication Process (incinerator). No approval will be given until compliance with Flood Damage Prevention is confirmed, which we don't yet have but we should know more next week. However, Planning has met with counsel and once that confirmation is supplied, the project is approvable from a Zoning standpoint and documentation will be provided to NC Division of Air Quality.
- 5) Consultant is preparing a presentation for the BOC on most recent Coal Ash GW Monitoring results for the August 20th meeting. I will share that information once I have it for the next ERAC meeting but you can also attend the August 20th meeting if you'd like that data sooner.
 - a. Coal Ash storage is up to 6.3 million tons as of June 2018
 - b. Summary from Dan's email
 - i. No GenX detections in JL
 - ii. PFOS and PFOA combined concentrations were found at 46 PPT in raw lake water, the EPA Health Advisory Level for combined is 70 PPT for these combined concentrations. After carbon treatment at the water plant, levels were reduced by 33%
 - iii. County is increasing activated carbon during treatment process to further reduce these contaminants
