WHEREAS, North Chatham School serves approximately 800+ students in grades K-8 and hosts many before- and after-school activities at 3380 Lystra Road, Chapel Hill; and

WHEREAS, outside of school hours the speed limit on Lystra Road in front of North Chatham School is 55 miles per hour; and


WHEREAS, the topography and course of Lystra Road and the location of various buildings and other obstacles limits the line of sight for motorists exiting the school; and

NOW, BE IT RESOLVED THAT:


