
PETITION TO CLOSE PUBLIC STREETS


Pursuant to N.C.G.S. §153A-241, the undersigned hereby petition the Board of Commissioners of the County of Chatham to permanently close a portion of the street or alley described hereinafter. The closing of this street is not contrary to the public interest and no individual owning property in the vicinity of this street would thereby be deprived of reasonable means of ingress and egress to his property.

The street proposed to be closed is as follows:

All of Holmes Street west of its intersection with Jones Street (SR 1932), and being a strip or parcel of land approximately 60' by 210' located between the lands of the Petitioners herein. Said portion of Holmes Street is more particularly described on the plat entitled "Map of Moncure and Vicinity" recorded in Plat Book 1, Page 1, and the plat entitled "Survey for Valent Lasater Dellinger Whatley Estate" recorded in Plat Slide 2005-353, Chatham County Registry, reference to which is hereby made for a more particular description.

**A RESOLUTION OF INTENT TO PERMANENTLY  
CLOSE A CERTAIN STREET IN MONCURE**

WHEREAS, it appears that permanently closing that portion of the certain street more particularly described herein within Moncure is not contrary to the public interest and that no individual owning property in the vicinity of said street or portion thereof proposed to be closed would thereby be deprived of reasonable access to his property;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Chatham as follows:

1. That pursuant to NCGS§ 153A-241 it intends to permanently close that certain street or portion thereof as follows:

All of Holmes Street west of its intersection with Jones Street (SR 1932), and being a strip or parcel of land approximately 60' by 210' located between the lands of the Petitioners herein. Said portion of Holmes Street is more particularly described on the plat entitled "Map of Moncure and Vicinity" recorded in Plat Book 1, Page 1, and the plat entitled "Survey for Valent Lasater Dellinger Whatley Estate" recorded in Plat Slide 2005-353, Chatham County Registry, reference to which is hereby made for a more particular description.

2. That a public hearing on the issue of such closure be, and it hereby is, scheduled for December 03, \_\_\_\_\_, 2007 and that a copy hereof shall be published once a week for three successive weeks prior to the hearing.

3. That a copy hereof shall be sent by certified mail to all owners of property adjoining said street as shown on the Chatham County tax records and a notice of said closure and public hearing shall be prominently posted in at least two places along the street.
