1. Selection of the recording secretary for the meeting minutes – Madison Ponder

2. Approval of meeting minutes – Minute edits were made and approved via Roll Call for October, November, and February of 2019.

3. Williams Corner EIA Review

- a. *Chair read compiled comments from ERAC members.*
- b. *The representative of the applicant provided commentary to the EIA Review.*

Comments that stood out throughout ERAC member review of the EIA:

- *Review Ray Bode's document for a complete list of the ERAC's conclusions regarding the EIA*
- Throughout the EIA there were gaps and incomplete explanation: (e.g., overall project details, utilities, sewer lines, wastewater management systems, discussion of alternatives, anticipated impacts, land disturbance, air quality, noise levels, etc.)
- The EIA often claimed to have minimal impacts to various impacts of the land and wildlife of this property, which is not realistic considering the changes that are proposed to be made.
- Various supportive materials, such as specific maps, permits, and referenced items not shown on maps, were not all included or clearly provided in the EIA.

Nicolas Robinson – representative of the applicant from Williams Corner project

- Planned the ERAC's review of the EIA document and will determine the next steps. Aimed to address points ERAC made.
- Stated that they have provided further documentation that goes beyond requirements of the EIA to the County, which is available for reference.

- Noted that 90 of 120 acres will be either preserved or open with only 30 acres disturbed with the intention to take the back 59 acres of the property and protect it. Complete plans for this conservation effort are TBD.

5. Announcements and updates from ERAC members

- EC: Greensboro was under order by the state to remove much more of the 1,4-dioxane. Greensboro has asked for a special order of consent to reach this goal. Industrial plants are using Greensboro wastewater treatment to process these chemicals.
