WHEREAS, the North Carolina Department of Transportation received in July 2005 and July 2006 an allocation of \$3,221,839 and remaining funds of \$0 from the previous **Secondary Construction Program**, a total of \$3,221,839 for Secondary Road Improvements in Chatham County for fiscal years 2005-2006 and 2006-2007. A public meeting was held on October 2, 2006 in the Chatham County Agriculture Auditorium on the expenditures of said funds:
