A Community Input Meeting will be held on Thursday, December 3<sup>rd</sup>, 2020 at 5:00 pm to discuss a proposed subdivision located on Old Graham Road, approximately 900 ft north of the intersection of Brook Green Lane and Old Graham Road. The meeting will be held at the North shelter of the Northwest District Park located off Woody Store Rd in Siler City, and will last approximately two (2) hours. The proposed subdivision will consist of 149 lots on 162 acres, with an average lot size of .41 acres. Water and sewer service for the proposed lots will be provided by AQUA. A representative will be available will be available to answer any questions there may be, and all interested parties are encouraged to attend to offer feedback. This letter is to invite you to a community meeting regarding a 149 lot residential subdivision on 162 acres we are proposing on Old Graham Road near your property, on Parcel Number 85448.00 . An informal community meeting will be held on Thursday, December 3rd, 2020 beginning at 5:00 PM at Northwest District Park, Northwest Shelter, and lasting approximately two (2) hours. Detailed directions are attached. Water and sewer service for the proposed lots will be provided by AQUA, with an average lot size of 18,000 sf (0.41 acres). Plans of our proposed development will be shown and you will have the opportunity to voice your concerns and ask questions of people knowledgeable about the details of our project. Our plans may be revised based on your input before we submit to the County.

This meeting is required as part of the County subdivision process; however, County staff will not participate in the meeting. We are planning to submit our official plans to the County Planning Department in the near future. You will receive a notice from the County about this submittal once the application has been made.



- Head North on Old Graham Rd/Old North Carolina 87 N
- Turn left onto Chicken Bridge Rd (1.4 mi)
- Sharp right onto NC-87 N (2.2 mi)
- Turn left onto Pete Thomas Rd/S.R. 1553 (2.9 mi)
- Sharp left onto Castle Rock Farm Rd (.1 mi)
- Turn right onto White-Smith Rd (.8 mi)
- Turn right onto Woody Store Rd (1.7 mi)
- Park entrance will be on the right.
- Community Meeting will be at the North Shelter inside the park.
