Program/DJJ Updates

Family Advocacy – Maria Soto

- Served 32 clients of 32 projected
- Intakes are by phone; signatures are waived; groups are virtual; some in-person contact w/masks & distancing
- Has been active with food distribution; conducting evaluations via Zoom meetings
- Tutoring is now available through CIS
- Challenges: internet at home is not available to everyone

Teen Court – Pablo Avendano

- Served 25 clients of 25 projected
- All services are remote; sentencing/restorative circles substitute for teen court

- Helping with college applications
- Intakes being done by Zoom; signatures waived; Google docs track participation
- Not getting referrals from schools since COVID restrictions kicked in

<u>Community Service and Restitution – Ramiro Martinez</u>

- Served 48 clients of 58 projected
- Stopped getting referrals from SROs
- Most everything is being done virtually now
- Now accepted as community service: documentaries, TED talks, virtual workshops, cards for senior center, paper projects on how COVID has affected them/community, home projects, babysitting, "thank-you" projects
- Internet access is still a challenge for many clients
- Law enforcement can refer directly to CS&R, up to 20 hours, this is to create more diversion opportunities; youth can also be placed at for-profit agencies, this can build job skills (*Denise*)

El Futuro – Lissette Guerrero

- Served 11 clients of 15 projected
- Everything being done virtually
- Some clients are uncomfortable sharing private information virtually or from home with others around
- Would like open doors for in-person appointments, with safeguards, as soon as possible

Wrenn House - Patricia Cardoso

- Served 2 clients of 10 projected
- Staff using masks in the house, social distancing; temperatures taken; bi-monthly, professional deep cleaning; hand washing; limited outings; limited visitors; staff members are tested for COVID; backup crew in place if any staff member tests positive; plan in place for when kids go back to school; more indoor recreational activities
- Admission suspended now due to positive test for staff member; waiting on results for other staff members
- Successes: strong communication; graduates continue to stay in touch
- Challenges: not much opportunity for in-depth connection with youth before arrival to soften culture shock

Psychological Assessments - Patricia Cardoso

- Served 3 clients of 10 projected
- Only virtual sessions at this time; difficult to keep kids engaged during lengthy virtual evaluations
- Have not had any referrals for a while

Juvenile Justice Data - Alison Uhlenberg

- 14 intakes out of 27 complaints in July
- RTA numbers are high largely due to out-of-county youth alcohol violations at Jordan Lake over the summer
