WHEREAS, in order that the Board, staff and public may plan as far in advance as is practical and reasonable the Board of Commissioners has deliberated the establishing of a meeting schedule for calendar year 2001; and

WHEREAS, the Board believes that this is the most appropriate manner to schedule the meetings to conduct the public's business.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Chatham, North Carolina that:

SECTION 1. The meeting schedule shown as Attachment A to this resolution shall be the official schedule of regular meetings for the Chatham County Board of Commissioners for calendar year 2001.





SUBJECT: Calendar Year 2001 Holiday Schedule

The holiday schedule for the Judicial Branch of Government for 2001 is the same as for the Executive Branch, allowing for twelve holidays.

Memorial Day	May 28, 2001	Monday
Independence Day	July 4, 2001	Wednesday
Labor Day	September 3, 2001	Monday
Veteran's Day	November 12, 2001	Monday
Thanksgiving	November 22 & 23, 2001	Thursday & Friday
Christmas	December 24, 25 & 26, 2001	Monday, Tuesday, Wednesday

Please remember that any variation in this schedule could result in overtime and premium pay costs, for which funds have not been budgeted. For this reason, any adjustment or change in this holiday schedule must be approved in advance by the Director. After receiving such approval, should court be held on a scheduled holiday requiring some of your employees to work, the employees will be granted an alternate day off, plus holiday premium pay. Please contact the AOC Human Resources Division if this occurs to determine who is eligible for holiday premium pay, and the procedures necessary to make appropriate payments.

Please inform all employees of this new schedule. In an office or courthouse where a bulletin board exists, please display this schedule for the benefit of all employees.
